NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Diplo's Run Club

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: K Street, 14th Street

PROJECT DESCRIPTION: Special Event Permit for a running event on November 2, 2025. The 5K course will start at K St at 13th St and finish on 14th St at K St. (see attached maps). The event would include a stage, canopies, temporary structures, sound amplification, music, generators, tables, chairs, fencing and/or barriers, onsite food preparation, food, a drone, portable restrooms, and recycling/trash containers. Noise associated with the event activities and set-up/dismantling would occur from November 6, 2025, at 7 AM to November 9, 2025, at 2 PM. Set up would occur over three days on November 6 & 7, 2025, from 7 AM to 5 PM, and from 4:15 AM to 8:30 PM on November 8, 2025. On November 8, 2025, the event would occur from 9 AM to 1 PM, dismantling would occur from 1 PM to 6 PM, and from 6 AM to 2 PM on November 9, 2025.

Road closures would be associated with this event, and would occur on November 8, 2025:

- from 4 AM until 11 AM and would include the following:
 - o 13th St. from K St. to J St.
 - o 14th from K St. to J St.
- from 8 AM until 10 AM and would include the following:
 - o 13th from J St. to Island Ave.
 - o Island Ave. from 13th St. to 14th St.
 - o 14th St. from Island Ave. to G St.
 - o G St. from 13th St. to 14th St.
 - o 15th from Island Ave. to C St.
 - o F St. from 15th St. to 14th St.
 - o 14th St. from F St. to C St.
 - o C St. from 14th St. to Park Blvd.
 - o Russ Blvd. from Park Blvd. to 16th St.
 - o Balboa Stadium Dr. Loop off Russ Blvd.
 - o 16th St. from Russ Blvd. to B St.
 - o B St. from 16th St. to 20th St.
 - o C St. from 22nd St. to 15th St.
 - o Park Blvd. (NB lane) from C St. to Russ Blvd.
 - o C St. from 19th St. to Park Blvd. (Bike lane closure only)

- Park Blvd. from C St. to Russ Blvd. (Bike land closure only)
- from 8 AM until 11 AM and would include the following:
 - 15th St. from C St. to Island Ave.
 - Island Ave. from 15th St. to 14th St.
 - 14th St. from Island Ave. to J St.
 - 14th St. from K St. to G St. (Bike land closure only)

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

2. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

The appeal application can also be obtained from the City Clerk, 202 'C' Street, 1st Floor Lobby, San Diego, CA 92101. This information will be made available in alternative formats upon request.

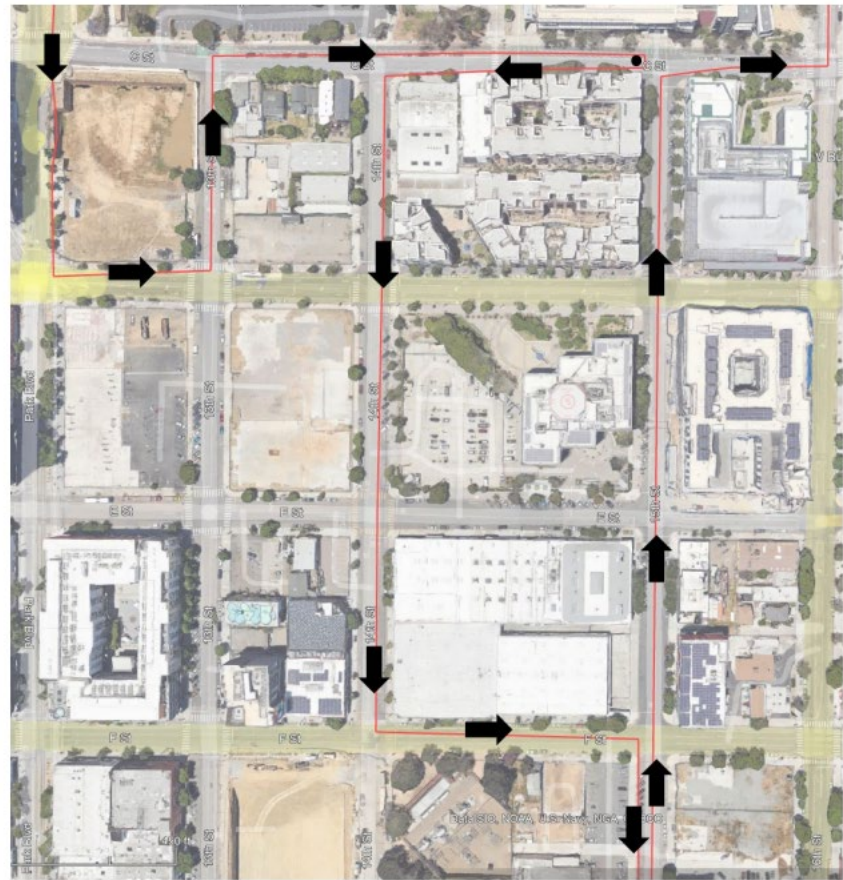
