# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

### **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - Challenge Walk MS Southern California

**COMMUNITY PLAN AREA:** Torrey Pines, University, La Jolla, Pacific Beach, Mission Beach, & Mission

Bay Park

**COUNCIL DISTRICT:** 1 & 2

**LOCATION:** City roadways within Torrey Pines, University, La Jolla, Pacific Beach & Mission Beach, Kellogg Park, South Palisades Park, Mission Park Beach, Ventura Cove Park, Vacation Isle, and Ski

Beach including rest stops (see attached map, route description & rest stops)

**PROJECT DESCRIPTION:** Special Event Permit for that portion of the Challenge Walk MS event that would occur within the City of San Diego's jurisdiction and would include the routes, rest areas, and finish area on November 8 & 9, 2025. The event would include routes, sound amplification, entertainment, generators, portable restrooms, canopies, tables, chairs, trash and recycling containers, and pre-packaged food. Noise associated with the event activities and set-up/dismantling within the City's jurisdiction would occur on November 8, 2025, from 6 AM to 4:30 PM on from 5 AM to 8 AM on November 9, 2025. Set up would occur from 6 AM to 10 AM on November 8, 2025, and from 6:30 AM to 10 AM on November 9, 2025. The two-day event would occur from 8:30 AM to 4:30 PM on November 9, 2025. Dismantling would occur from 1:30 PM to 6:30 PM on November 8, 2025, and from 9 AM to 4:30 PM on November 9, 2025.

The walk route within the City of San Diego is indicated in the attached map and route description.

No road closures would be associated with this event however, some traffic delays could be expected during the walk event. The event would adhere to "rules of the road".

### **ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**October 28, 2025**).

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.




