This item involves litigation related to Measure C, a November 2022 ballot measure to exclude the Midway-Pacific Highway Community Plan Area from the 30-foot height limit in the Coastal Zone. Save Our Access seeks a writ of mandate to invalidate Measure C's enabling ordinance due to the City's alleged failure to comply with the California Environmental Quality Act (CEQA). The City Attorney's Office will update the Mayor and City Council on the status of litigation and seek direction.
