## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Consent to License Agreement between Southern Sudanese Community Center and the City of San Diego.

**PROJECT DESCRIPTION:** Under the terms and conditions of the License Agreement, The City hereby grants a License with a term from the Effective Date through the day before the third (3rd) anniversary of the Effective Date. The Premises are Licensed to LICENSEE solely and exclusively for the purposes of operating and maintaining the Premises as a community center to provide employment assistance, youth education, language classes, health education, acculturation program and conflict resolution for Sudanese refugees in the City of San Diego and San Diego County.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which allows the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified, no significant effects on the environment were identified, the project is not adjacent to a scenic highway, no historical resources would be affected by the action, and there are locations listed on GeoTracker and EnviroStor within 1,000 feet of the address in question. While these locations are listed, the proposed projects would not involve ground disturbance, which would expose potential hazardous materials, and as such, would not preclude the use of a CEQA exemption pursuant to Section 65962.5 of the Government Code.
