Veterans with service dogs are 66% less likely to be diagnosed with PTSD. There's not enough room for service dogs in these units and not enough parking.

  - 2. Gris has 7 bills on Newsom's desk.
  - 3. AB253 permitting reform would allow homeowners and developers to use licensed private professionals to do inspections if it's taking too long from city
  - 4. AB474 Shared Housing Act supports nonprofit home sharing programs for seniors
  - 5. AB1103 on veteran mental health to streamline care process
  - 6. AB629 school district equipment inventory will save school time and money by reducing paperwork
  - 7. Civics contest for 4th, 8th, and 10th graders. Deadline Sept 17. Details here.

  - 2. City adopted a coastal resilience plan. Will affect some coastal areas with sea walls, plantings, traffic/parking changes to reduce erosion

  - Council passed plan to charge for parking in Balboa Park. Whitburn voted against it and had proposed changes to the plan that were not put in place. Will begin Jan 1. Higher rates for non-residents, free/reduced parking for staff and volunteers. <a href="mailto:lnsideSanDiego.org">lnsideSanDiego.org</a> for details
  - 2. Traffic calming measures are coming to NP. Quick build demonstration coming soon with a few groups including AARP. More info will come on this soon.
  - 3. Whitburn submitted memos to the transportation dept regarding intersections at Louisiana/Madison and Utah/Upas for always stops. Transportation dept will review these requests and submit a work order if feasible. This should take 2-4 months.
  - 4. Transportation dept made improvements at Normal/Park/El Cajon intersection including new striping and bigger signs to make the turns easier to follow. \$600k for feasibility study for longer-term fixes. Traffic signal will be upgraded this year.
  - 5. <u>Community rec needs assessment</u> to better understand needs of the community. There's a survey online people can fill out.
  - 6. Caltrans/City agreement to clear encampments only covers freeways near downtown, the 5 and the 94. 1 year pilot program. State will reimburse the city up to \$400k in expenses to clear these encampments.
  - 7. Progress on shade structures in the mini park.
  - 8. No response yet to our stormwater letter.
  - 9. Arnold St resident sent some emails to the city about traffic abatement issues including someone who hit a child with their car.
  - Community parking districts are facing some changes on how they can spend their money
  - 11. University Ave mobility project should be completely done, but there's an issue with bus lane striping.
  - 12. El Cajon/Mississippi light project no update on timeline

- A. **Information:** Aaron Null, Founder & Executive Director Street Stewards, presentation streetstewards@gmail.com
  - 1. Litter pickup group founded in 2018 in OB. They're now in 11 communities across the county. On their website you can adopt streets in the area and record cleanups.
- B. **Information:** Jacqueline Penhos, presentation related to Hugs and Bags, a nonprofit that helps unhoused families and students in North Park
  - Started this org 10.5 years ago for unhoused youth ages 5-22. There are 10k unhoused students in SD, many in this area. H&B supplies lots of needs, physical and mental health. Meal distributions every Monday 10AM-12PM at Trolley Barn Park with donated food from restaurants.
  - 2. Food and toiletries are most important things to donate.
  - 3. Clients normally come to H&B through word of mouth but can also connect via social media or a call/text at 619-799-1078
  - 4. <u>Donations and volunteering can be coordinated on the website</u>.
- C. **Information:** 32nd and Thorn Street Mural Art Project: petition to be circulated; identifying local artists and designs; setting up a fundraiser to sponsor the project
  - 1. Expressive arts company is going to reach out to the city to assess feasibility of the mural like they've done in downtown areas.
  - 2. Mural would be in the intersection with durable paint.
  - 3. There are now crosswalks and red curbs on every corner of the intersection.
  - 4. Initial funding and maintenance are the issues to be worked out on this project.

  - 1. Goal of traffic calming is to reduce the downsides of vehicle use. NP should be designed for safety of all street users.
  - 2. City of SD general plan has a priority on safe, secure, and walkable neighborhoods.
  - 3. Residents can fund these projects if they can gather the money, also CIP and grants
  - 4. There are lots of different tools we can request, need to understand the tools so we can fit the tool to the need
