DIRECTOR'S REPORT

Michael Prinz, Development Services Department -

"The last Planning Commission hearing was held on September 25th. At the hearing, the Commission heard two items, a Community Plan Amendment Initiation to redesignate a 1.32-acre site from Right-Of-Way to Office and Visitor Commercial in the Mission Valley Community Plan. The request would also consider removing the site from the Community Plan Implementation Overlay Zone, the Specific Plan Subdistrict, and a Specific Plan Amendment to remove the site from the Atlas Specific Plan. The Commission approved the initiation by a vote of 5-0-2, with Commissioner Mahzari recused and Commissioner Miyahara absent."

"The Commission also recommended to the City Council approval of the Midway Rising project, which includes a General Plan Amendment and Community Plan Amendment, a Specific Plan, Rezone, Development Agreement, Municipal Code Amendments, Site Development Permit, Easement Vacation, and other actions to allow for approximately 4,254 housing units, including 2,000 affordable units, a 16,000-seat multi-purpose entertainment center, public spaces, and 130,000 square feet of commercial uses. The Commission voted to recommend approval with a modification to the development agreement to move the transit improvements to Phase 1. The Commission made the recommendation by a vote of 6-0-1, with Commissioner Miyahara absent. That concludes my report."
