PLEASE ACCEPT THIS AS A NOTICE TO INFORM YOU, as a property owner, tenant or interested citizen, that the Council of the City of San Diego, California will conduct a public hearing, as part of a scheduled City Council meeting, on the following project:

The Mitigation Fee Act requires an annual report on Development Impact Fees to be presented to the City Council. Specifically, the City is required to make specific information available to the public and establish certain findings related to Development Impact Fees that have been in the account and unspent for five years or longer. In compliance with these requirements, the item being heard includes accepting the <u>Development Impact Fees Annual Report-Fiscal Year 2024</u> in accordance with California Government Code section 66006 and findings related to unexpended balances as required in California Government Code section 66001, including the allocation of funds for identified projects that serve the purpose of the projects for which the fees were originally imposed. In addition to a comprehensive report on Development Impact Fees and other City Planning managed funds, this item includes a request for Council approval for appropriating Development Impact Fees towards a list of specific Capital Improvement Projects in Carmel Valley and Del Mar Mesa.

The proposed action to accept the DIF Annual Report for Fiscal Year 2024 and make findings pursuant to California Government Code sections 66001 and 66006, is not a project pursuant to CEQA Guidelines Section 15378(b)(5), as it is an organizational or administrative activity of government that will not result in direct or reasonably foreseeable indirect physical changes in the environment. As such, it is not subject to CEQA pursuant to CEQA Guidelines Section 15060(c)(3).

The proposed resolution to appropriate and spend funds from the Carmel Valley FBA and Del Mar Mesa is not a "project" pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15378(b)(4) as it is a government fiscal activity which does not involve any commitment to any new, specific project which may result in a potentially significant physical impact on the environment. Thus, this activity is not subject to CEQA pursuant to CEQA Guidelines Section 15060(c)(3). The appropriation and expenditure of these funds are fiscal activities that will not result in the commitment to any new, specific project that may cause a physical change in the environment. The Solana Highlands Neighborhood Park-Comfort Station Development, Carmel Grove Neighborhood Park Comfort Station and Park, Carmel Knolls Neighborhood Park Comfort Station-

Development, Carmel Del Mar Neighborhood Park Comfort Station–Development and the Sage Canyon Neighborhood Park Improvements have received previous approvals which were reviewed under CEQA and these budgetary actions do not change the scope of those projects, so there is no potential for new environmental impacts which would need further evaluation under CEQA. For the Del Mar Mesa Resource Management Trail, environmental review per CEQA will be completed at the appropriate future time in accordance with CEQA Guidelines Section 15004.

If you wish to challenge the Council's actions on the above proceedings in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence to the City Council at or prior to the public hearing.
