Item 9: Information Items (1:14)

- a) Presentation on <u>Inclusive Public Engagement Guide</u>, Kevin Borja, Senior Planner and Vanessa Tang, Associate Planner, City Planning Department
 - a. The Inclusive Public Engagement Guide is now at the public review stage (as of November 2025) and aims to support all City departments in improving how they engage with the public. Its key purposes are to increase operational efficiency, ensure decisions reflect community needs and desires, build public trust, and increase participation among underrepresented groups. The Guide emphasizes engagement principles such as building community relationships, clear communication, inclusion, commitment to engagement, and transparency. It also distinguishes between public outreach and engagement, focusing on the latter as a more participatory process. The document is available for public review through October 19, and a PDF version will soon be released to aid in public commentary.
 - b. During board discussion, several questions were raised about implementation and resources. The Guide is primarily advisory and currently has no dedicated funding or resource allocation. All staff are encouraged to use its engagement steps and will receive related training. The Guide also addresses coordination with legally required processe and includes metrics to track engagement outcomes like reach and participant experience. The City is exploring how to integrate the Guide into customer service training and will follow up on questions related to its impact on boards and committees, as well as the potential for an annual report.

- b) Resilience Topic: Presentation on Grid Resilience by Dr. Lorenzo Kristov, Independent Consultant
 - a. Board Member Morgan introduced Dr. Kristov for a presentation on electric service resilience, highlighting that the City has contracted to build eight microgrids—four at resiliency centers and four at fire stations, with half already completed. The presentation emphasized the community's dependence on reliable energy resources and the importance of both islanding (operating independently from the grid) and grid hardening. Dr. Kristov underscored the need for energy justice—ensuring communities can share in ownership and operation of local energy assets—and recommended expanding solar generation where practical. He also proposed compensating customers who install larger solar and battery systems to share surplus energy with nearby residents, creating benefits for both participants and the broader community.
 - b. Dr. Kristov's broader vision included building community microgrids to ensure uninterrupted essential services, retrofitting neighborhood resilience centers, and fostering local energy planning capacity. He advocated for bottom-up energy planning—designing community-level systems first, then developing regional transmission for remaining needs. Current regulations, however, hinder multiproperty and community microgrid viability. Near-term actions include advancing local projects, engaging communities around energy justice, collaborating with city and county planners, and creating better business and financial models. The discussion also covered how to prioritize projects in high-risk or fire-prone areas and opportunities to establish microgrids in new developments before utility connections are built.
- c) Resilience Topic: Presentation on Water Supply Resilience by Meena Westford, Director of Imported Water, San Diego County Water Authority (CWA).
 - a. Ms. Westford emphasized the critical importance of water and the interconnected nature of the regional water system, which depends heavily on imported sources and aging infrastructure. She noted that developing new water supplies is extremely costly, and efforts are underway to augment water resources across the Southwest. Next-generation water solutions will rely on partnerships and improved accounting systems to better manage shared resources. Board members raised several points: interest in stormwater capture, concerns about growing demands in hotter regions like Arizona, and the need to link physical, fiscal, and equity-based resiliency. Proposition 218 was mentioned as a key barrier to equitable project financing since it restricts cost-sharing across user groups.
 - b. Ms. Westford also highlighted the importance of maximizing existing infrastructure before investing in new projects, both for cost efficiency and environmental protection. She provided an update on the concluded litigation between the Metropolitan Water District) and the County Water Authority, confirming continued water delivery through existing infrastructure. Board Member Morgan asked about installing solar panels over canals carrying water, such as the Turlock Canal, and Ms. Westford noted that they are monitoring those efforts closely. The meeting concluded with an official City statement expressing appreciation for the San Diego County Water Authority's presentation while noting that the City has a different

perspective on certain aspects of water resiliency planning and plans to share more about its own climate-aligned approach at a future meeting.

Visit from Chida Warren-Darby, Director of the Office of Boards and Commission (1:37)

Ms. Warren-Darby addressed the Board's concerns about delays and lack of transparency in filling vacancies on boards and commissions, explaining that she is considering proposing a Municipal Code change to allow the Mayor's Office to directly recruit candidates when City Councilmembers have not acted on nominations for district-designated seats. She noted that her office sends monthly reminders to Councilmembers about vacant or expired seats and clarified how term expirations work—using the analogy of a chair with a running clock that continues regardless of whether the seat is filled. While appointments can take 30 to 60 days to process, she emphasized that members may continue serving in their roles even after their official term has expired, with the "expired" status being only a technical label on the website.

Board Member Meyer agreed, noting that the remaining content can stay as context. Board Member Garrett suggested keeping the city's actions as contextual information, possibly under a revised title.

 - c. Board Members discussed ways to improve the report's clarity and accessibility:

 Board Member Meyer suggested adding more hyperlinks to meeting minutes, presentations, and other resources for public readers. Board Member Gong recommended integrating all recommendations into a single paragraph that includes context, stakeholders, and the engagement plan. Board Member Garrett proposed building more time for collaboration in next year's monthly meetings. The Board also edited the document live to enhance readability, including changing "City Action" to "City Context," formatting recommendations to stand out, and adding relevant hyperlinks.
