2. Nonprofit Formation Discussion

Gustavo Bidart, Economic and Community Development Manager, Civic Community Partners

- Gustavo Bidart led the continued discussion regarding nonprofit formation documentation.
- Kevin Davis gave an overview on the organizational resolution packet which includes:
 - Apply for 501(c)(3) status, obtain an Employer Identification Number, file a
 Statement of Information, adopt a Conflict of Interest Policy, elect officers,
 authorize opening a bank account and designating check signers, and registering
 with the Registry of Charities and Fundraisers.
- Gustavo shared several updates including Civic soon having a license agreement to use the San Ysidro building space, opening a PO Box in San Ysidro, obtaining insurance quotes soon and opening a bank account soon.
- The group agreed with adding Gustavo Bidart as a designating check signer on the account.
- With a motion from Miguel Aguirre and a second from Norman Jester, the group voted to approve the organizational resolution packet.

 - October The voting ballots will be mailed to assessment payers which will include the annual meeting details.
 - November The annual meeting (elections) will be held. The group decided to adjourn the November 12, 2025 Updates Meeting and replace it with the annual meeting. The meeting will be at 5pm, the location is not yet determined.
