 - 1. Subcommittee submitted feedback report to EIR;
 - S/C did not believe that site can fit 100 homes, EIR states, original 45 homes best use of property, recommend 45 homes with 12 affordable homes, added smaller lots proposed, for 100 homes, 3 feet side yard, total 6 feet between homes, noted that the homes to be built similar to surrounding homes, which it is not, did not indicate why need deviation of extra five feet in height, also zoned high fire zone, therefore not allowing 5 foot non-combustible material.
 - ii. Reduce house architectural design options from 6 to 3, several not consistent with surrounding homes. Bulk and Massing Scale visually detracting from surrounding communities.
