VI. Informational Items –

- a. Introduction of new Commissioners

- b. Review of July 29, 2025 with Chief Wahl and staff
 - i. Commissioners Davis, Friedt and Urushima-Conn shared information around the visit with Chief Wahl and staff in which they discussed the clearing of Sexual Assault Evidence Kit backlog and the recruiting of women in the SDPD.
- c. Review of August 9, 2025 First Inaugural Women's Tea
 - i. Chair Friedt and the Commissioners thanked the Marketing, Events, and Programming Chair Carrillo and members, Commissioners Urushima-Conn and Wong for a fabulous event. Commissioner Wong reported that the feedback she received was all positive and that her staff really enjoyed assisting with the event.
 - ii. Discussion regarding timing and content of Second Women's Tea. Commissioner Cherry suggested the topic of financial literacy. Commissioner Wong mentioned that some attendees suggested menopause as a future topic.

VII. Action Items –

- a. Subcommittees
 - i. Policy & Advocacy: Works to identify, research, and advocate for policies that promote equity and improve the status of women and girls in the community. This group monitors local, state, and national legislation and partners with officials and organizations to support relevant policy initiatives.

 - a. Short update on CEDAW ordinance progress was given.
 - **ii.** Community Outreach: Focuses on building relationships with the community through partnerships, events, and ongoing engagement. This subcommittee ensures that diverse voices are heard and included in the commission's work, especially those from underrepresented or marginalized groups.

 - **iii.** Events & Programming: Plans and coordinates public events, workshops, and campaigns that educate and empower women and girls. This team ensures events align with the commission's mission and support community involvement, awareness, and celebration.

- b. Chair Friedt encouraged the subcommittee members to meet regularly as each committee will be asked to give an update at the monthly meeting.
- c. Subcommittee responsibilities as outlined in the bylaws:
 - i. Each subcommittee shall meet regularly to carry out the stated projects, programs, and objectives for the subcommittee as provided by a majority of the Commissioners.
 - ii. Subcommittees can add, cease, or rename their activities with the approval of a quorum of Commissioners.
 - iii. All subcommittee members must be members of the Commission. Any subcommittee may, by a majority vote of its members, utilize as technical advisors, individuals who are not members of the Commission, for the purpose of furthering the work of the given subcommittee. Advisors shall not be compensated and shall not cast any votes in subcommittee or Commission meetings.

- iv. No subcommittee shall have more than four members.
- v. Discussion on When2Meet Poll results for monthly meeting.
 - 1. Chair Friedt presented the results from the When2Meet Poll. The Commissioners discussed the pros/cons of the poll and expressed how difficult it would be to find a date/time that works for everyone. None of the Commissioners wanted have weekend meetings. The option of keeping the current Friday schedule was also on the table and discussed.
 - 2. After much discussion, the Commissioners felt that the best option would be to keep the current schedule; the Second Friday of the month, from 12-1:30 PM.
 - 3. Chair Friedt asked the Commissioners to consider holding the meetings to one hour, with the option of the subcommittees to meet 30 minutes before or after.
 - 4. A motion was made to keep the regular meetings on the second Friday of the month, but change time from 12:00 1:00 PM, with option of sub-committee meetings before/after. Location would remain the Serra-Mesa/Kearny Mesa Branch Library. Second was received. Motion passed unanimously
- vi. Discussion to change the October 10, 2025 meeting to Oct 27, 2025, Same location and time.
 - 1. Motion was made and seconded. The change was approved unanimously.
- vii. Discussion to adjourn the December 12, 2025 meeting.
 - 1. Motion was made to adjourn the December meeting. Only Chair Cherry opposed. Change was passed December meeting will be adjourned

VIII. Discussion Items

- a. Next Steps: Survey on Women's Disparities in the Workforce
 - i. Commissioners discussed whether or not to draft and distribute another survey. Commissioner Davis thought a new survey would be beneficial as the previous one was not widely distributed. Commissioner Cherry felt that the City of San Diego had enough data available to use, it just needed to be collected and analyzed. After additional discussion it was decided to put a new survey on hold. Commissioners were encouraged to collect any data/information. Chair Friedt/Fatima will work on how to store and share the information.
- b. Strategic Planning for 2026
 - i. Chair Friedt proposed a Special Strategic Planning meeting to guide the Commission "where do we go from here". The 3 most important issues for women have already been identified from the survey: Affordable housing, affordable childcare & public safety/security.

- Would like to identify our Commissions top 3 policy priorities, which help guide our work on the subcommittees.
- ii. A motion was made to hold the regular scheduled January meeting from 10:00 am 10:30 and the strategy meeting from 10:30 am 12:30, on Saturday, January 3^{rd} , 2026. Location TBD. The motion was seconded and passed unanimously.
- iii. A motion was made to adjourn the January 9th regular meeting. The motion was seconded and passed unanimously.
