## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT DESCRIPTION:** The project is requesting a Site Development Permit for the installation of one new Alpha PN-4 system enclosure (52 inches [in.] x 26 in. x 24 in.) by Charter Communications, which would house two new Alpha XM-3 power supplies and six new 12V Alpha 4.0HP batteries. The enclosure would be located on a new precast concrete pad (6 in. x 30 in. x 30 in.) within the public right of way at 3853 1/3 Modoc Street. The project would include all associated conduits and cables for commercial power and connection to existing Charter equipment, as well as removal and replacement of portions of the sidewalk. The existing power supply enclosure would be removed once all of the new equipment has been installed and powered. The site is zoned CO-1-2 and designated Office Commercial in the Clairemont Mesa Community Plan. Additionally, the project is located within the Airport Land Use Compatibility Overlay Zone (Montgomery Field), Clairemont Mesa Height Limit Overlay Zone, Transit Priority Area, Airport Land Use Compatibility Plan Airport Influence Area (Montgomery Field – Review Area 2), Federal Aviation Administration Part 77 Noticing Area, and Very High Fire Hazard Severity Zone.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego Planning Commission

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15302 (Replacement or Reconstruction) and 15303 (New Construction or Conversion of Small Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego determined that the project would qualify to be categorically exempt from CEQA pursuant to CEQA Guidelines Sections 15302 (Replacement or Reconstruction) and 15303 (New Construction or

Conversion of Small Structures). CEQA Guidelines Section 15302 was deemed appropriate since the project would remove an existing power supply enclosure and replace it with a new power supply enclosure within the same site area. The new equipment would have substantially the same purpose and capacity as the equipment replaced. The project would also remove and replace sidewalk within the same site area. Similar to the telecommunication equipment, the new sidewalk would have substantially the same purpose and capacity as the sidewalk replaced. CEQA Guidelines Section 15303 was deemed appropriate since the project would install a small new concrete pad, conduits and cables. The exceptions listed in CEQA Section 15300.2 would not apply considering the project is not located within a particularly sensitive environment; would not significantly contribute to a cumulative impact would not result in any physical changes visible from a scenic highway; is not included on any list compiled pursuant to Government Code Section 65962.5 for hazardous waste sites; and the project would not cause substantial adverse change in the significance of a historical resource.
