Tentative Map to convert two existing single dwelling units into condominiums on a single lot located at 3112 Natchez Avenue. The 0.19-acre site is in the RM-1-1 zone, the Airport Land Use Compatibility Overlay Zone (Montgomery Field), the Clairemont Mesa Height Limit Overlay Zone, the Airport Influence Area - Montgomery Field (Review Area 2), the FAA Part 77 Noticing Area, and a Very High Fire Hazard Severity Zone within the Clairemont Mesa Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act.

Site Development Permit to build a new 4,418-square-foot two-story house with a 577-square-foot detached garage and a 552-square-foot accessory dwelling unit above the garage located on Toyon Road, APN-461-430-0700 within the RS-1-1 (Residential Single) zone, the Transit Priority Area, the Parking Impact Overlay Zone, an Airport Influence Area (Review Area 2-Montgomery Field), the FAA Part 77 Notification Area, and the Airport Land Use Compatibility Overlay Zone (Montgomery Field) and contains environmentally sensitive land in the College Area Community Plan.

ITEM 3: 403 SEA RIDGE DRIVE - PROJECT NO. PRJ-1109256

Staff: Martin Mendez City Council District: 1 Plan Area: La Jolla

Coastal Development and Site Development Permit for the demolition of an existing single dwelling unit, and construction of a new, 4,861-square-foot (sf), two-story single-dwelling unit, attached 800-sf Accessory Dwelling Unit (ADU), and associated site improvements. The 0.2-acre site is located at 403 Sea Ridge Drive in the RS-1-7 zone, the Coastal Overlay Zone (Appealable Area, First Public Roadway), the Coastal Height Limitation Overlay Zone, the Parking Impact Overlay Zone, the Sensitive Coastal Overlay Zone, and the Transit Area Overlay Zone within the La Jolla Community Plan and Local Coastal Program Land Use Plan. This development is within the Coastal Overlay Zone and the application was filed on January 23, 2024.

This project was determined to be categorically exempt pursuant to Sections 15301 (Existing Facilities), 15302 (Replacement or Reconstruction) and 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act.

# **HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS**

## TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. Those participating virtually may NOT cede time to others participating in person or virtually.

## **HOW TO PROVIDE WRITTEN COMMENTS:**

**For Agenda Items and Non-Agenda Public Comment:** Submit using the <u>webform</u>, indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 500 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer <u>website</u> for further instructions.

**Written Materials:** Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

# **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1<sup>st</sup> Floor, San Diego, CA 92108.
