ITEM 1: *COAST WALK LOTS 2 & 17 – PROJECT NO. PRJ-1074172

Plan Area: La Jolla

Coastal Development Permit and Site Development Permit to construct a new two-story, 5,478-square-foot single-dwelling unit and a new 440-square-foot detached accessory dwelling unit with garage, demolish a portion of an existing tennis court, and associated site improvements. The 0.45-acre site is located on lots 2 and 17 of Coast Walk (APN 350-13102-00 and APN 350-131-29-00), within the Residential-Single Unit (RS-1-7) zone, the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Appealable Area), the Parking Impact Overlay Zone, the Sensitive Coastal Overlay Zone, , a Transit Priority Area, and a Very High Fire Hazard Severity Zone within the La Jolla Community Plan. This development is within the Coastal Overlay Zone, and the application was filed on October 20, 2022.

Mitigated Negative Declaration (MND) No. 1074172/SCH No. 2025080815 was prepared in accordance with the California Environmental Quality Act Statute and Guidelines. A Mitigation Monitoring and Reporting Program (MMRP) for Historical Resources (Archaeology) and Tribal Cultural Resources will be implemented to reduce impacts to below a level of significance.

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*
