- MTRP will be fully staffed. A conditional offer for park ranger will be made within the week.
- Oak Grove Trail Resurfacing Project POs have been approved and trail work will begin in July.
- East County Advanced Water Purification Project Orion construction group has been very communicative at addressing public concerns.
- Addressed public safety issues regarding hiking in the heat. Discussed the installation of thermometers at major staging areas or the Visitor Center and continued use of signs.

## Open Space Report - Erika Ferriera, Deputy Director, Open Space Division

 Open Space Division and Park Ranger Division are currently completing reference checks to fill Park Ranger vacancies.

## MTRP Foundation Report - Jennifer Morrissey, Executive Director, MTRPF

- MTRPF received Nonprofit of the Year Award from Chris Ward; Jennifer met with Wade Crowfoot, CA's Natural Resources Secretary, in Sacramento to receive the award.
- 30x30 Conference will be in San Diego in August. Hike for attendees to be hosted at MTRP.
- MTRPF received 2 million dollars for exterior improvements at MTRP Visitor Center.
- Entering second year of invasive brush removal by RECON Environmental; primrose removal will begin at Kumeyaay Lake.
- Interpretive panels are being finalized and will provide English and Spanish text, with a QR code linking to 12 threshold languages.
- Events: just wrapped up photo contest awards, upcoming Dark Sky event and Volunteer Appreciation event

## <u>Citizen's Advisory Committee</u> – *Kevin Loomis, CAC Chair*

- Master Plan Update- 13 priority projects determined throughout the park. Kevin will discuss each in more detail at next Task Force meeting.
- Max Lenail Memorial Bridge is paused. Looking to other sources of funding: possible grants, public and private sources.
- City Council approved to keep Lake Murray Reservoir open.
- West Sycamore Staging Area Groundbreaking scheduled for fall will include picnic tables, restrooms and lot resurfacing.
