PROJECT NAME: Design Consultant Services for Linda Vista Library Patio Improvement

COMMUNITY PLAN AREA: Linda Vista

COUNCIL DISTRICT: 7

LOCATION: The proposed project would be located at 2160 Ulric Street.

PROJECT DESCRIPTION: Mayoral action to allow award of a design consultant services contract for engineering-related services at the existing City of San Diego Linda Vista Library. The proposed project would reconfigure the existing outdoor early learning patio to provide new meeting and craft spaces, additional seating, a new exit gate, a concrete patio, a new perimeter wall, landscape and hardscape improvements, drainage enhancements, and Americans with Disabilities Act (ADA) upgrades. The contract scope includes data review, project coordination, underground utility exploration, subsurface geotechnical investigation, laboratory testing, geotechnical analysis, and reporting for the Linda Vista Library Patio Improvement Project.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review which determined that the project meets the statutory exemption criteria set forth in CEQA State Guidelines, Section 15262 (Feasibility and Planning Studies) for approval of the design consultant services contract, which includes subsurface geotechnical services.

The appeal filing fee must be United States Postal Service (USPS) postmarked within five (5) business days of the date the appeal is filed.

Deposit the fully completed appeal application (including grounds for appeal and supporting documentation) to the City Administration Building – Public Information Counter (Open 8:00 a.m. to 5:00 p.m. Monday through Friday excluding City-approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00 p.m. on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer. Please include the project name on the memo line of the check/money order.
