SUBJECT: PENASQUITOS CREEK NEIGHBORHOOD PARK PROPOSED GENERAL

DEVELOPMENT PLAN AMENDMENT

### **SUMMARY**

<u>Issue</u> – Should the Parks and Recreation Board recommend approval of the Proposed General Development Plan (GDP) Amendment?

<u>Department Recommendation</u> – Recommend approval of the proposed General Development Plan (GDP) Amendment for Penasquitos Creek Neighborhood Park.

Other Recommendations – The following groups have reviewed and considered the proposed project. Actions taken and recommendations made by these groups are listed under Discussion below.

On September 25, 2025, the Rancho Penasquitos Community Recreation Group voted unanimously (5-0-0) to recommend approval of the proposed GDP amendment.

- <u>Fiscal Impact</u> Funding in the amount of \$2,000,000 has been identified for the implementation of this project.
- <u>Water and Energy Conservation Status</u> The proposed project complies with all water and energy conservation guidelines contained in Council Policy 200–14.
- <u>Climate Action Plan (CAP) Impact</u> The proposed project complies with the Climate Action Plan (CAP).
- <u>Strategic/Tactical Equity Plan Impact</u> The proposed project complies with the Strategic/Tactical Equity Plan.
- <u>Environmental</u> This activity is statutorily exempt from CEQA pursuant to State CEQA Guidelines, Section 15262 (Feasibility and Planning Studies).

PENASQUITOS CREEK NEIGHBORHOOD PARK PROPOSED GDP AMENDMENT October 29, 2025 **BACKGROUND** 

Penasquitos Creek Neighborhood Park is located in the Rancho Penasquitos community planning area on Camino Del Sur and Park Village Road in Council District 5. The park currently contains a children's playground, basketball court, multi-purpose sports field, picnic tables, perimeter walkway, and security lighting. Penasquitos Creek Neighborhood Park was initially developed in 1991 and the playground was renovated in 2003. The park is on dedicated park land.

### DISCUSSION

Engineering & Capital Projects Department staff and design consultant conducted two public workshops with the community. The first workshop was held on July 24, 2025, where City staff and design consultant shared alternative designs for the prefabricated comfort station and took input from the community on the proposed design alternatives. A second Community Recreation Group workshop was held on September 25, 2025 to present the preferred alternative design for community input and CRG recommendation. At this meeting, the Rancho Penasquitos Community Recreation group voted unanimously (5-0-0) recommending the approval of the proposed GDP.

During these workshops, staff and design consultant provided alternative locations and orientations for the new comfort station, answered questions, and took input on design recommendations as well as neighborhood concerns. Specifically, vandalism, maintenance, security, and possible loitering were identified as concerns the community had. Overall, the community was very receptive with the proposed restroom addition to the park.

The proposed General Development Plan Amendment (Attachment 1) would provide a new prefabricated comfort station which include two accessible stalls with baby changing tables, sinks, and drinking fountain. The prefab building will also provide a storage room for the park's maintenance crew.


