STANDARD OPERATING PROCEDURES AND RESPONSIBILITIES OF RECOGNIZED COMMUNITY PLANNING GROUPS POLICY NO.: 600-24

Voting Members of CPGs are expected to treat each other, members of the community, and City staff in a professional manner.

Skyline-Paradise Hills Community Planning Group Operating Procedures:

Section 6.1 Professional Conduct

The planning group and its voting members will conduct themselves reasonably and professionally and refrain from disrupting the public process as set forth on the planning group's agenda.

Section 6.3 Disorderly Conduct

In the event that any planning group meeting is willfully interrupted by a person or group of persons, so as to make the orderly conduct of the meeting infeasible, the planning group may first cause removal of the individual or individuals. If that is unsuccessful then the planning group may order the meeting room cleared and continue in session on scheduled agenda items without an audience, except that representatives of the media shall be allowed to remain. The planning group may also readmit an individual or individuals who were not responsible for the disruption.

- ☐ Compile infrastructure requests from neighborhood residents by December 20, 2025. Submit a prioritized list to the City by February 1, 2026.
- ☐ Monitor CPC and Council committee items and pick at least one item per month to track or comment on. Start immediately.

Policy Matters

Affordable Housing & Tenant Protections

- The City updated rules for Accessory Dwelling Units (ADU) and Junior ADUs (JADU). These changes align with state law and affect fees and safety rules.
- **Why it matters:** This can change how many rental units may appear in our neighborhoods and may affect parking and local services.

Economic Development & Small Business

- The City's Land Development Code (LDC) is being updated with many changes across the city.
- **Why it matters:** Changes could affect local businesses in Lomita and Jamacha by changing allowed uses or parking rules.

Public Safety & Infrastructure Matters

Public Safety

- Key problems in our area: street lighting outages, pedestrian safety, illegal dumping, and emergency response needs.
- **What you can do:** Report problems to 311 and [Get It Done](#) (City non-emergency requests) and email the Planning Group liaison so we can track hot spots.

Infrastructure & Urban Planning

- The City is working on catching up with repairs for streets and sidewalks. Some neighborhoods are lower on the priority list.
- **What we can do:** Collect problems (potholes, broken sidewalks, storm drains) and submit them as a group to Public Works.

Land Development Code (LDC) — Summary of Proposed Updates

LDC stands for Land Development Code. It is the City rulebook for zoning, building, parking, signs, and more. The City published a Citywide Discussion Draft of LDC updates (2025). Below are key items that likely affect our planning area.

- ADU / JADU rules & Development Impact Fees (DIF) for ADUs

What it does: Aligns local ADU and JADU rules with state law and updates fees.

Why it matters: Easier or different rules for home owners adding ADUs. This affects density, parking, and sewer/water planning.

- Refuse, Organic Waste, and Recyclable Materials Storage rules

What it does: Requires new homes to include space for trash, recycling, and organic waste.

Why it matters: Helps reduce illegal dumping and keeps streets cleaner.

- Parking regulations & screened parking facades

What it does: Requires parking structures facing streets to be screened and clarifies rules when sidewalks or promenades change.

Why it matters: Affects street look and where cars park if commercial blocks are redeveloped.

- Promenades and active sidewalks — accessible parking relocation

What it does: Allows accessible parking to be moved up to 500 feet when creating promenades or active sidewalks.

Why it matters: Ensure parking for people with mobility needs still works for them.

- Fire-safety setback clarification for residential zones

What it does: May increase side or rear setbacks where needed for fire safety or emergency access.

Why it matters: Important for hillside lots in Skyline Hills and safe evacuation.

- Definitions & unit counting

What it does: Clarifies how the City counts the number of dwelling units on a lot.

Why it matters: Affects how many units are allowed and whether conversions need permits.

- Administrative citations, nuisance, and civil penalties increases

What it does: Raises fines for code violations and abandoned property.

Why it matters: Gives City tools to fix chronic problems like illegal dumping, but property owners must be informed.

- Inclusionary and off-site affordable housing rules; AB 812 implementation

What it does: Implements state changes affecting affordable housing rules in new projects.

Why it matters: Affects how affordable housing is included in new buildings near transit or commercial areas.

- Development Impact Fees (DIF) adjustments

What it does: Clarifies park fees and other fees paid by new projects; allows certain fee updates yearly.

Why it matters: New projects may pay fees that help build parks and sidewalks in our area.

Memo to Support Jamacha Neighborhood Council (JNC)

We support the Jamacha Neighborhood Council's urgent request to correct and update all official maps to accurately reflect the name and boundaries of the Jamacha community as listed in the Skyline-Paradise Hills Community Plan.

Inaccurate mapping has caused serious problems, including:

- Confusion in emergency evacuation zones
- Misreported crime statistics and insurance rates
- Transit Priority Area (TPA) confusion
- Distorted real estate listings and home values
- Public safety risks at Viewcrest Dr. and Imperial Ave
- Incorrect demographic reporting
- City projects being assigned to the wrong communities

While there has been progress in updating the one District 4 community map, all other city maps, and GIS mapping systems remain incorrect and do not comply with the current Skyline-Paradise Hills Community Plan, dated June 30, 1987. We urge all City Departments and GIS mapping companies to work with the Jamacha Neighborhood Council and Community Planning Groups (CPG) to resolve these issues immediately.

We endorse this request and ask all City Departments and relevant authorities to act now for the benefit of our neighborhoods.

Correspondence Requesting Community Support for Accurate Jamacha Name and Mapping of the Jamacha Boundaries

Dear Community Leaders and Representatives,

The Jamacha Neighborhood Council is seeking your support in our ongoing efforts to correct and update official maps that inaccurately represent both the name of our community as well as the boundaries of our community.

We believe that clear, accurate mapping of neighborhood boundaries is essential for effective city planning, resource allocation, and community recognition.

Background

Recent reviews have revealed that official City of San Diego maps, as well as those produced by third-party mapping contractors, continue to mislabel or conflate Jamacha with neighboring areas such as Lomita. This has led to confusion and misrepresentation of both communities, impacting everything from local services to neighborhood identity.

Concerns

Specifically, we are advocating for Jamacha to be labeled correctly as “Jamacha”—eliminating variants such as Jamacha/Lomita, Jamacha- Lomita, or Jamacha Lomita—and for the boundaries between Jamacha and Lomita to be clearly defined.

These mistakes affect:

Emergency evacuation zones 🚒

Crime statistics and insurance rates 🚓

Transit access and development approvals 🏠

Real estate listings and home values 🏡

Public safety at intersections like Viewcrest & Imperial Ave 🚦

Distort all Demographic Information

Stormwater, Planning Dept. DSD are all reporting projects in wrong communities including Encanto in Chollas Valley CPG.



Our Request

- We ask your Community Planning Group, neighborhood council or community based organization to join us in formally requesting that all city departments and contracted mapping companies (including DSD, ZAPP, ARCELLA, Master Mobility Plan, and the Blue Print for Success) revise their maps to accurately reflect the boundaries of the Jamacha community.

We are urging the Planners Commission; Land Use Housing; Transit Agencies; and following Elected Officials:

Mayor, Todd Gloria; Councilmember Henry L. Foster and all Councilmembers; San Diego Association of Governments (SANDAG); San Diego Metropolitan Transit System (SD MTS); the City of San Diego Mapping Authorities.

Call to Order

Chair Jenkins called the meeting to order at 18:14 hours.

Roll Call

Approval of Agenda and Minutes

- Member Preuss motioned to approve the agenda. Member Shepherd seconded. The motion passed unanimously.
- Member Preuss motioned to approve minutes from September 9, 2025 meeting. Member English seconded. The motion passed unanimously.

Non-Agenda Public Comment

- None.

Representative Reports

- Officer Chris Jones (Community Relations Officer) announced he has a new partner on board (Officer Martinez) distributed a community resource sheet, and referred the public to the Get it Done App for parking problems.
 - Chair Jenkins asked about ICE activities and SDPD responsibilities. Officer Jones said there is no collaboration with ICE unless ICE calls for help.
- Korral Taylor (Mayor's Office) reported on new affordable housing projects, including new units in Midway area with on-site resources.
- Bruce Williams (City Council District 4) provided the following information:
 - Introduced Jacquelyn Kennedy as the Policy Advisor for District 4, who reported about the postponement of water/sewer rates increases.
 - The City budget priority process was discussed, as well as 2025 achievements in District 4.
 - Announced the San Diego Lost Neighborhoods exhibit at the San Diego History Center.
 - Provided an update on capital improvements to the Martin Luther King, Jr. pool, which should be completed by the end of the year.
 - Reported on new parking rates downtown for special events and the new trash bins.

- Chair Jenkins asked about cost of parking for disabled. It will be free for disabled people.
- The public asked about trash can costs when you have extra bins over the three and it was discussed that no refund is available.
- Councilmember Foster's office will be participating in Get It Done days over the next 3 days this week.
- The latest issue of the newsletter for District 4 was distributed recently.
- Mariah Jameson (County District 4) reported on an older adult resource fair being held on November 17, actions from the Board of Supervisors, and webinars for procurement services and contracting opportunities with the County.
- Dr. LaShae Sharp-Collins (California Assembly District 79) reported on her achievements, including \$60 million and 6 bills signed by the governor and successfully securing money in the state budget for workforce and apprenticeship programs and worker protections.
 - Member Preuss asked about AB planning bills that allow increased density.
 - Member Houston referred to the erosion of the scope of CEQA review and lack of public notice.

Community Planners Committee Report

- Member Preuss reported that the CPC created a subcommittee to review the changes to the Land Development Code (LDC). He suggested that a representative of the construction industry should be on the CPC and/or CPGs.
 - Chair Jenkins asked which committees in Sacramento work on the LDC. Korral Taylor said Assemblymember Chris Ward sits on the Housing Committee.

- Chair Jenkins referred to events and information included in the Community Brief and Action Report that was attached to the agenda, including the City's Inclusive Engagement Guide and Urban Collaborative Project meetings.
