- C. Information Item: CPC Chair and Vice Chair meeting with Director of Planning Department Tips for Planning Groups, Victoria LaBruzzo. This past month has been a great opportunity to meet with city staff and answer many of our questions about how to become a better partner with the city planning department. This opportunity really shows a spotlight on the abyss that separates planning groups and city planning departments. Communication is one area that both sides agreed to improve, including asking the right questions and sending documents to the correct person and department. Some of the lessons learned are to get into the planning process early, be welcoming and non-adversarial to build a better relationship with all interested parties, including builders. Our level of education must increase to learn what to expect from builders and why they behave the way they behave. We need to learn who to send documents to the correct person in the correct department. The Community must build a relationship with the builder to get our concerns and issues addressed prior to going into the draft EIR stage.
