NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

PROJECT NAME: West Ramp Spider Hangar Rehabilitation

COMMUNITY PLAN AREA: Kearny Mesa

COUNCIL DISTRICT: 7

LOCATION: The proposed project site would be located within the existing Montgomery-Gibbs Executive Airport (MYF), located at 3750 John J. Montgomery Drive.

PROJECT DESCRIPTION: Mayoral approval to award a construction contract for rehabilitation of approximately 56,000 square feet of existing asphalt pavement in the western areas of the airport, including ramps, hangers, and taxiways. The proposed project would also install a new concrete drainage swale and riprap energy dissipator at the southern end of the existing pavement. Proposed excavation would be up to approximately 36 inches in depth. Staging of construction equipment would be limited to paved and developed areas of the airport. The project occurs adjacent to the City's Multi-Habitat Planning Area (MHPA) and will be required to comply with the MHPA Land Use Adjacency Guidelines as specified in Section 1.4.3 of the Multiple Species Conservation Program's (MSCP) Subarea Plan.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: This activity is categorically exempt from CEQA pursuant to CEQA State Guidelines, Sections 15301 (Existing Facilities); 15302 (Replacement or Reconstruction); 15303 (New Construction or Conversion of Small Structures); and 15304 (Minor Alterations to Land).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Engineering & Capital Projects Department

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review which determined that the project meets the categorical exemption criteria set forth in CEQA State Guidelines, Section 15301 (Existing Facilities), which allows for the operation, repair, maintenance or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of the existing use, such as the rehabilitation of the existing asphalt pavement; Section 15302 (Replacement or

Reconstruction), which allows for the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, such as the rehabilitation of asphalt pavement; Section 15303 (New Construction or Conversion of Small Structures) which allows for the construction and location of limited numbers of new, small facilities or structures, such as the installation of a concrete swale and associated energy rip rap dissipator; 15304 (Minor Alterations to Land) which allows for minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees, such as minor trenching and backfilling to support pavement rehabilitation and installation of new drainage facilities; and where the exceptions listed in Section 15300.2 would not apply.
