SUBJECT: MANDATORY PATROL RIFLE TRAINING SHOOT – FALL 2025

SCOPE: ALL MEMBERS OF THE DEPARTMENT

DEPARTMENT PROCEDURE AFFECTED: 1.41

Portions of this document are deemed by the San Diego Police Department to be records of security procedures and are exempt from disclosure under the California Public Records Act (CPRA), Government Code Section 7923.600 or are deemed by the San Diego Police Department to be exempt from public disclosure because the public interest served by not disclosing the information clearly outweighs the public interest served by disclosure, pursuant to California Government Code section 7922.000.

The Firearms Training Unit will be conducting a mandatory training shoot for all patrol rifles. All personnel who are currently authorized to carry patrol rifles (department issued and personally owned) on duty are required to attend the training shoot. **The shoot will begin** (**Deleted – records of security**). Dates available for the shoot will be posted on the Department's Success Factors training site titled "*Rifle Training Shoot-Fall 2025*." Immediate supervisors will ensure their personnel who are authorized to carry a patrol rifle attend the shoot.

Personnel must arrive fifteen minutes prior to the scheduled training time for their rifle to be inspected for authorized accessories, necessary adjustments, and serial number verifications. Personnel who arrive late will be turned away and directed to reschedule the training.

<u>Upon arrival, all personnel must wait in the parking lot for Range Staff to escort them inside the building. Do not carry any uncased rifles into (Deleted – records of security) without an escort from Range staff. Loading and unloading firearms in the parking lot is strictly prohibited. All loading and unloading will be done on the firing line under instruction.</u>

<u>Motor Officers in uniform may carry their uncased rifle into (Deleted – records of security) only in the following condition: rifle slung, magazine removed, bolt locked open to the rear.</u>
All other rifles must be carried in rifle cases or rifle bags.

Personnel who are currently authorized to carry a personally owned rifle must attend and will be provided with a department "pool" rifle to conduct the shoot. Personally owned and unsuppressed rifles will not be permitted for use during this training shoot.

Personnel must bring their duty handgun with three pistol magazines and their department-approved rifle with at least three magazines. Supervisors and officers working patrol and other uniformed assignments must wear their approved full duty equipment. Supervisors and officers working investigations and non-uniformed assignments are expected to shoot with the holster that is worn in everyday use; non-uniformed assignments may NOT use patrol style leather gear. Blackhawk "Serpa" or any other holsters with unlocking mechanisms manipulated by the shooter's trigger finger, shoulder holsters, and cross-draw type holsters are not authorized. Additional equipment such as tourniquets, etc., shall not be attached to duty holsters.

Tactical "drop down" holsters/thigh rigs will not be used unless that equipment is worn in the normal course of their duties and authorized by their unit policy.

Any city rifle found not to be in a state of "operational readiness" due to lack of maintenance (officer negligence) will be taken from the officer and returned to the Range Armory. Individual officers' profiles will be updated with maintenance flags in the Range database. Sworn personnel who fail to attend this mandatory training will be considered "out of compliance" and no longer allowed to carry their rifle on duty.

All personnel must supply their own eye protection. Sunglasses are not allowed to be used for the department shoot. Ear protection (foamies) will be provided. However, over the ear protection is recommended due to the acoustics of the indoor range.

<u>Personnel not in compliance with the above instructions, including unauthorized</u> <u>modifications to holsters, weapons and accessories, will be required to correct equipment</u> deficiencies and re-schedule the shoot at a later date.
