NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit -Convoy Rising A Lunar New Year Kickoff Celebration

COMMUNITY PLAN AREA: KEARNY MESA

COUNCIL DISTRICT: 6

LOCATION: Culdesac of Vickers Street off of Convoy Street

PROJECT DESCRIPTION: Special Event Permit for a new year kick off celebration that would include cultural performances, food, onsite food preparation, entertainment, sound amplification, and the temporary use of canopies, tables, chairs, a drone, portable restrooms, and trash/recycling containers that would occur on cul-de-sac of Vickers Street off of Convoy Street on February 8, 2026. Noise associated with the event activities and set-up/dismantling would occur from 11 AM until 9:30 PM on February 8, 2026. Set-up would occur from 11 AM until 3 PM, the event would occur from 3 PM until 8 PM, and dismantling would occur from 8 PM until 9:30 PM.

Road and parking closures would be associated with this event and would occur on February 8, 2026, from 11 AM until 9:30 PM and would include:

- Vickers Street (West of Convoy Street) to be closed starting at 7760 Vickers Street and into the culdesac (road closure)
- Vickers Street (West of Convoy Street) to be closed starting at 7760 Vickers Street building, into the culdesac, and ending parallel at 7747 Vickers Street (parking closure)

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
