SUBJECT: Fiscal Year 2026 Second Quarter Employee of the Quarter Selections

It is my pleasure to announce the winners of the Parks and Recreation Department's Employee of the Quarter (EOQ) winners for the Second Quarter of Fiscal Year 2026.

As you know, winners are nominated by their peers, supervisors, and managers each quarter. Then, each Deputy Director reviews their division's nominations for eligibility and chooses up to six nominations to forward to the Parks and Recreation Department Rewards and Recognition Selection Committee. Winners are selected by the Rewards and Recognition Selection Committee (see attached roster of committee members) based on some or all the following criteria: exceptional work performance, customer service, professionalism, cooperativeness, work schedule availability and attendance, and dedication.

Each selectee receives one day (8 hours) of Discretionary Leave and a \$300 cash award. Please note that all Discretionary Leave and monetary awards are prorated for part-time and hourly employees, per City policy.

I am excited to recognize the following **Parks and Recreation Department Employees of the Quarter** for the second quarter of Fiscal Year 2026:

- **Eddie Aguiluz Meza**, Equipment Operator 2, who is also known as "Little Eddie" exemplifies what it means to be a dedicated and public servant. He is assigned to the Support Services Unit, yet he regularly volunteers to assist with tasks well outside his job scope. He's hands-on during concrete pours, emergency responses and last-minute work requests. He takes initiative to ensure safer operations and higher-quality outcomes. His supervisor frequently receives emails from area managers expressing their appreciation for Eddie's dedication, and strong work ethic. Eddie is humble, polite and respectful and is highly regarded by his peers. Eddie is quoted as saying, "I'm here to help and make things better for us as a team and for us to shine as a work unit. We are in this together." This statement truly reflects his character, teamwork, and commitment to our organization's success;
- **Franchot Broy**, Utility Worker 2, who demonstrates outstanding teamwork, professionalism and a strong commitment to getting the job done right. Franchot has graciously stepped into OCA assignments on numerous occasions, serving as both Park Utility Supervisor and Equipment Technician II. His willingness to support the department beyond his assigned role speaks volumes about his dedication. He takes great pride in serving the public, especially when it comes to maintaining and repairing playgrounds. He excels in pour-in-place rubber surfacing repairs, delivering high-quality work that directly impacts public safety and accessibility. Recently, he led a major project involving the full demolition and re-

layout of deteriorated pour-in-place surfacing at 28th St Park. The playground's attenuation surfacing is no longer compromised and is now restored to full functionality;

- **Gary Burns**, Grounds Maintenance Supervisor, who demonstrated exceptional initiative and leadership after identifying a noticeable decline in one of his park sites, he proactively coordinated with Citywide Maintenance and multiple vendors to secure the necessary materials and resources to complete a full turf renovation. The project was successfully executed with outstanding results, significantly improving the condition and appearance of the site. Gary possesses extensive institutional knowledge with park operations, historical understanding, and unwavering commitment to excellence, which he consistently shares with staff to support both daily operations and long-term success. His helpful nature and team-first attitude reflect a strong work ethic and a genuine commitment to serving both his colleagues and the community;
- **Mary Ekhaml**, Recreation Leader 1, who with her exceptional performance in the San Carlos-Allied Gardens area demonstrates dedication, leadership, and a strong commitment to serving the community. Mary Beth played a key role in planning and executing the October Halloween Fest, helping ensure a fun, organized, and welcoming event for families. She assisted with Toys for Tots registration and contributed significantly to the winter events, helping create engaging programs. She built an excellent community rapport, connecting with participants and families to create a positive, inclusive environment. As the basketball and volleyball lead, she manages league drafts and officiates games with fairness, organization, and a strong emphasis on sportsmanship and safety. Her leadership and reliability make her an invaluable asset to the team and community;
- **Portia Gregory-Burnette**, Associate Management Analyst, who recently stepped in to train her supervisor on how to properly cancel and reverse goods receipts, thoroughly explaining each step of the process. Portia also assisted her supervisor and another analyst in gaining a better understanding of the new EUNA City budget system software. Although instructions were provided, they did not include all the necessary steps. Portia identified the missing steps, shared the process, and ensured a smooth transition to utilizing the new system, allowing the team to successfully meet their deadline. Her patience, clarity, and strong analytical knowledge made the learning experience smooth and effective. Portia consistently maintains a pleasant and welcoming attitude, and her positive attitude, dedication, and willingness to support others make her an invaluable member of the MAD team;
- **Walter Heyward**, Grounds Maintenance Worker 2, who oversees the maintenance at Golden Hill Recreation Center, Montclair, and Cedar Ridge Parks- all of which require diligent care as they are all visited frequently by community members. At Golden Hill, Walter is known to most neighbors by name. He is a constant presence ensuring the park is free of graffiti, trash, and wayward trees and brush. He is a listening ear for patrons to issue requests and bring attention to any issues. He is an exemplary GMW who takes great pride in his work. He isn't afraid to ask for help from staff if he needs it, he volunteers to help with work projects at other sites and has helped train other grounds staff at our sister sites. Walter is an exemplary GMW who takes great pride in his work, gives 110%, and is an exceptional employee who goes above and beyond his regular duties every day;
- **Kevin Lewis**, Golf Operations Assistant, in a short period of time, he has proven himself to be one of the most dependable employees in our golf operations, always prepared, focused, and ready to contribute. With this increased responsibility, he has continued to exceed expectations by stepping up to help train new employees, ensuring they understand procedures, expectations, and the high level of service we strive to provide.
