CHAIRPERSON'S REPORT:

1. Hourglass Fieldhouse Joint-Use Committee: Still reviewing the operations manual. Mentioned getting blocks for the swimming pool since the pool is over 25 years old. Fields were closed for maintenance till August 11. The College is planning to hold a Pow Wow on March 21, 2026. Next meeting for Joint use is scheduled for August 21.
2. Community Parks I Area Committee: Group is now called Park Talk San Diego and includes all the City of San Diego Recreation Centers. The meeting is online once a month instead of meeting at all these different centers.
3. Mira Mesa Park Phase 2-3 Expansion Committee: Phase 2 a big rock quarry was put in next to the fire station to deal with storm water abatement. Phase 2 seems to be moving along well.

Council District 6 Report:

Council Representative:

- Not present – Community updates sent to City staff below.
- Mira Mesa Community Park Phase II Improvements
 - Some of the work done included the roof on the equipment building complete, Environmental health and quality inspections of the small pool done, and shotcrete work was finished at the large competition pool.

- July report with more details has been posted to the website.
- Street Reconstruction Group 1801 (as of August 1st)
 - The following segments of Gold Coast Drive are scheduled for paving:
 - August 4-12: San Ramon Drive to Westonhill Drive
 - August 11-19: Lipscomb Drive to Baywood Lane
 - Other work to the streets will begin once paving is complete.
 - Water main relocation under Gold Coast Way is currently underway and is expected to be completed by the end of August.
 - Crews will install new storm drains and complete final paving after the water main relocation.
 - The project is tentatively projected to be completed in early spring 2026.
- Salk Neighborhood Park (Maddox)
 - No new updates, the legal issues with the shade structure continue to be the primary reason for the delay.

- 110 classes for swim lessons.
- No lessons again till summertime.
- Had the Junior Adaptive Sports Camp here in June for their yearly camp.
- During Fall there will be less time for public.
