103. Request additional mitigation for the East County Water Purification Project to restore access to Father Junipero Serra Trail – *Kevin Loomis, CAC Chair*

- The motion was moved and seconded. (Murphy, Hutsel)

WORKSHOP ITEMS – None

INFORMATION ITEMS

301. East County Advanced Water Purification Project Update – *Rebecca Abbott, Engineering Manager, East County Advanced Water Purification Joint Power Authority*

- Three crews: Fusion, East and West.
- Goal is to optimize project schedule and minimize impacts to wildlife.
- East Crew: working near the Dam.
- West Crew: working near Visitor center and Mission Gorge.
- Slip line work should take approximately 6-8 weeks per section. 14 sections. Estimated to be done in 2028.
- 42 wild life crossings have been installed under the pipe and more to come.
- Through access has been affected on FJST. Unsure when it will be accessible for the duration of the project.
- Access issues: most visitors are following signage but some are not. Fences are being knocked over inside the trenches, signs are being moved, and workers are experiencing unpleasant interactions with visitors.
- More outreach will occur with updates on project.
- Comments: Concern for public safety and wildlife. Concern about the open trenches and the fences are not around all sides. Suggestion of hiring a security guard and/or have sheriff patrol around open trenches.
- Crews will install more fences around trenches and make sure they are secured properly.
- March -September is bird nesting season and more construction will be put into place for noise cancelling and mitigating disruption to breading birds.
- CAC believes the current project has been modified slightly, therefore a motion regarding the concern of public safety and access on FJST to see that the contractor minimizes the issues discussed and that they will be monitored to insure that these concerns be taken care of. This will be an action item for next CAC meeting.
