### AREA MANAGERS REPORT

Area Manager Hannah Turner reported the following: Olive Grove construction is almost finished. It will most likely be done in October. The new fiscal year budget is in. She shares that no Assistant Center Directors needed to be cut. The center hours didn't need to be cut either. She is working to combine the CAG meeting with South Clairemont Recreation Center and Tecolote Recreation Center. She is also working toward letting all user groups know of the meeting.

### COMMUNICATIONS

Mr. Rashid talked to neighbors saying that dust is coming into their houses. He brought up the likelihood of grass at Cadman Dog Park. Jerome Abbott mentioned the success of Allied Gardens and Poway having grass at the dog parks. Mr. Segal mentioned the irrigation system needing to work properly for the grass to come back. Jerome mentioned that tumble wood can possibly be placed there. Hannah Turner also mentioned that the water rates have increased so we had to put different times and take away some time. Troy will set up a meeting with the District Manager and Mr. Rahsid and Mr. Segal to go over irrigation at Cadman.
