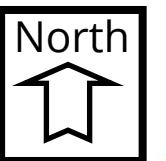
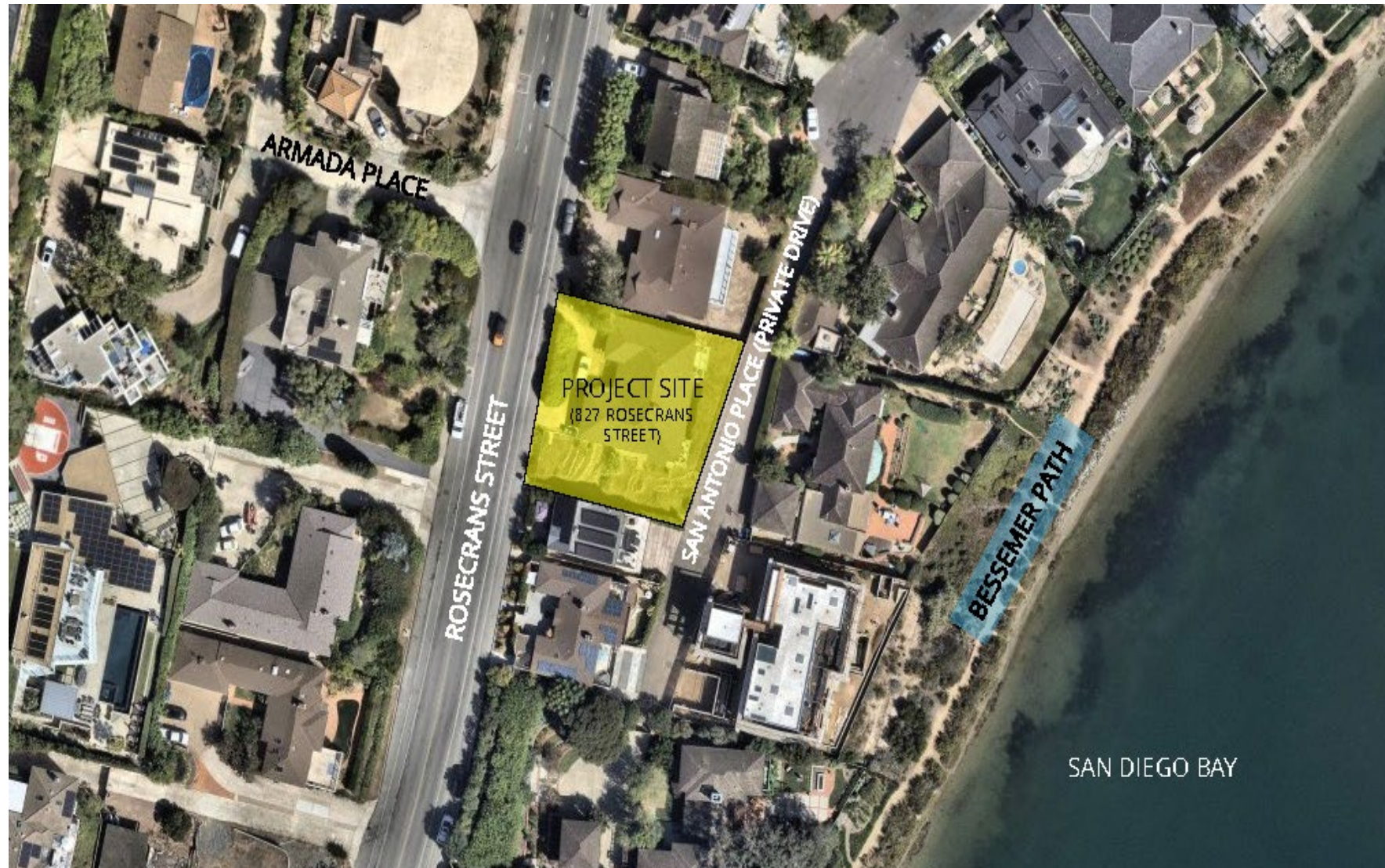

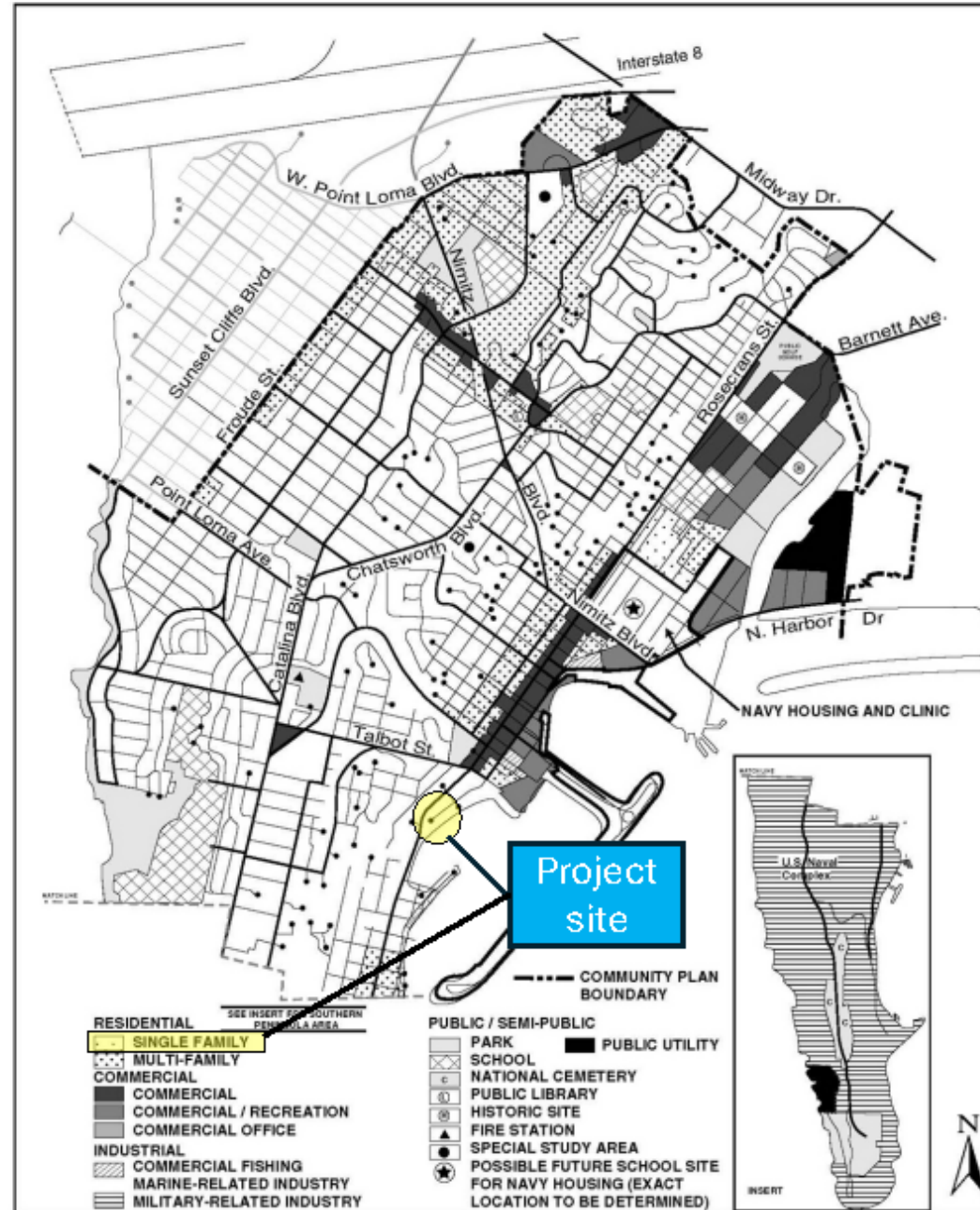
Project Scope

 - New 1,367 square foot addition to create a new upper level.

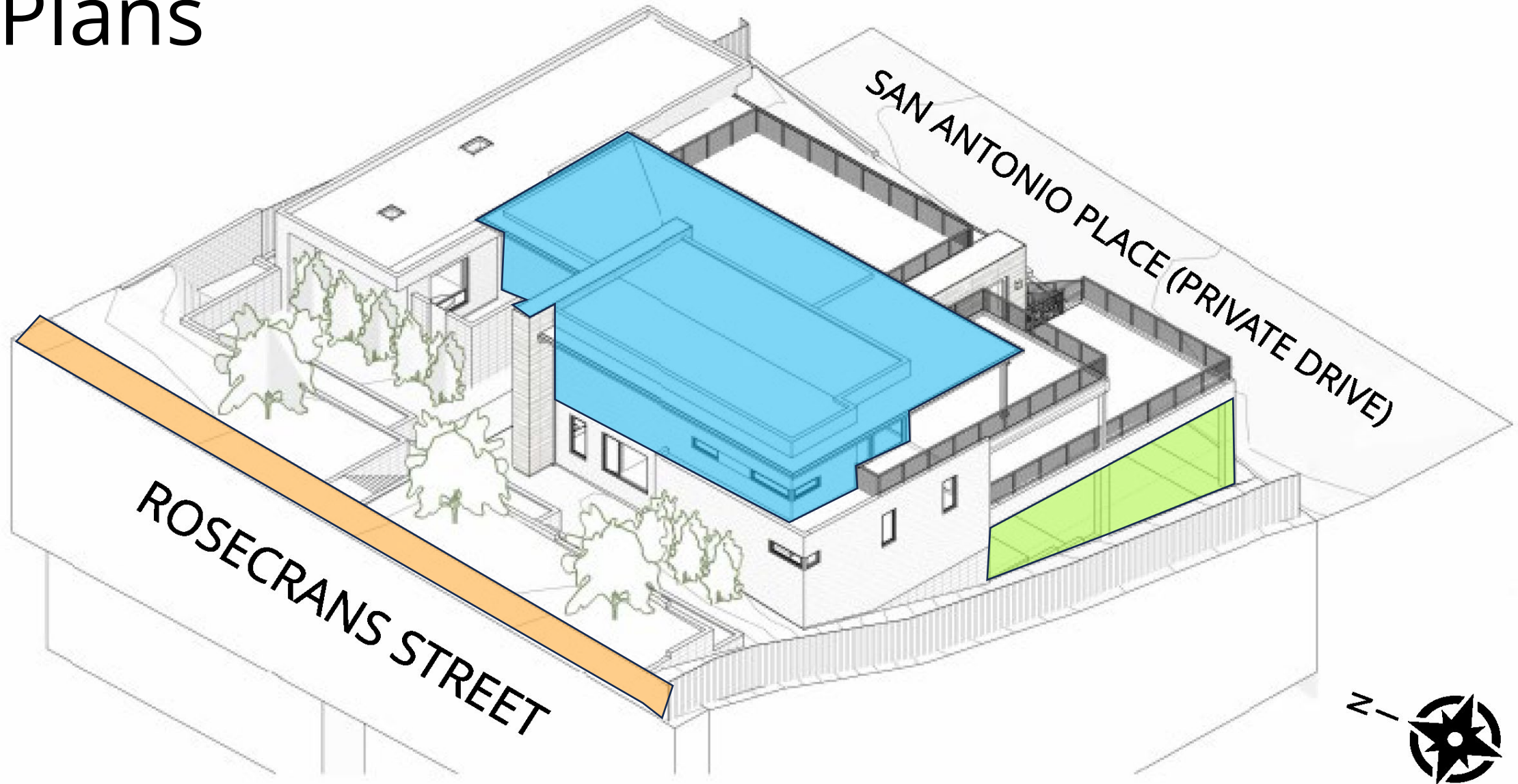

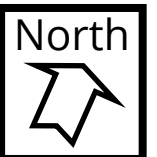
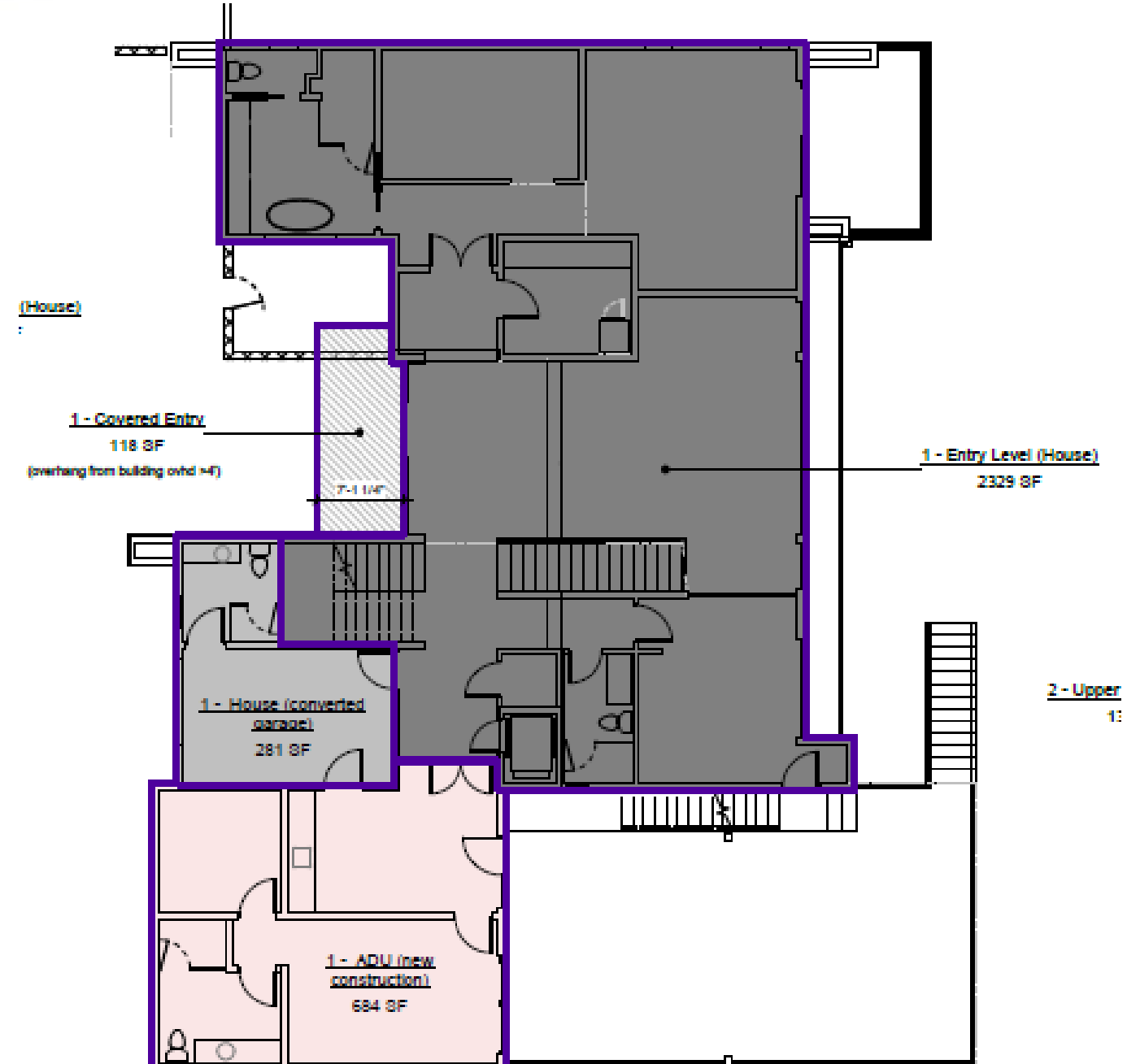
Land Use Plan
