- Infrastructure survey passed out for upcoming 5-year outlook pertaining to upgrades.
- The city operates off of data driven decisions. Passed out QR codes for various District 8 updates and surveys (Infrastructure Priorities; Environmental Services; Office of the City Auditor; Get it Done App
- City is interested in a community input to response time of emergency such as the storms of Jan 2024. City auditor has released a report on what could have been done better in the city/county.

SAN DIEGO POLICE DEPARTMENT

Chris Jones

- Will provide resources for unhoused population
- Let the public know police cannot just remove vehicles people are living in, technically that is their “home”. Police need to be able to offer resources such as a shelter bed. However, if there is no shelter bed available then that is another dilemma.
- Discussed Safe Parking Options which is a hot topic. Some spots that were suggested previously Chollas Lake, Skyline Library, areas attached to the city.

- Continues to support community through various efforts such as sport fee sponsorship.
- Continues to take care of the roses around the park. Concerns surrounding theft of roses.
