In general, the Subcommittee is not a voting entity, but rather a forum for discussing issues and policy matters related to historic resources and their preservation. Comments at the meeting do not predispose future positions on any matter by the Historical Resources Board.*

*Members of the public will be allowed an opportunity to speak, for up to one minute each, at the end of the Subcommittee's discussion on an agenda item. Each member of the public is required to state their name and the organization (if any) that they represent prior to their one-minute presentation.*

4. Creation of an Ad Hoc Subcommittee: The Board's adopted procedures state that ad hoc subcommittees may be established on an as-needed basis. *"Ad hoc subcommittees may be stand alone subcommittees of the Board, combined subcommittees including representation from other agencies, or subcommittees of other agencies with Board representation by one or more Board members. Ad hoc subcommittees typically provide the Board with recommendations related to the purpose for which the subcommittee was established... Establishment of ad hoc subcommittees... shall be by a majority vote of the Board at a regular or special Board meeting."* Staff is requesting that the Board consider the creation of an ad hoc subcommittee whose purpose is to make recommendations to the Board on changes to the [Guidelines for the Application of Historical Resources Board Designation Criteria](#) as part of the Preservation & Progress initiative.

5. **Subcommittee and Ad Hoc Subcommittee Appointments:** The Board's adopted procedures state that "Membership on the standing subcommittees shall strive to match expertise and interests to the extent possible, but shall also strive to allow maximum participation by Board members. The minimum number of Board members appointed to any standing subcommittee shall be three, and the maximum shall be five... Appointments to the standing subcommittees, including chair appointments, shall be made once a year, or as vacancies occur, by the Policy Subcommittee, and ratified by a majority vote of the Board at the next available Board meeting." Staff is requesting that the Policy Subcommittee provide a recommendation to the HRB on appointments to all subcommittee positions, both standing and ad hoc if created, based on the interest and availability of the Boardmembers.
