NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- CRSSD Music Festival - Spring 2026

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: County of San Diego Waterfront Park & surrounding roadways; Harbor Dr., Pacific Hwy

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within the City of San Diego's right-of-way jurisdiction that would be associated with a two-day music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on March 14 & 15, 2026. The event permit would be issued by the County.

Road closures & parking prohibitions associated with the event would include:

- Ash Street from Pacific Highway to Harbor Drive from 6 AM on March 14, 2026, until 11:45 PM on March 15, 2026.
- One lane of northbound traffic on N. Harbor Drive from Ash to Grape Street & two northbound lanes of traffic remain open, two northbound right turn lanes remain open at Grape) from 6 AM on March 9, 2026, until 12 PM on March 17, 2026.
- the bike lane east side of Harbor Drive between Ash and Grape Street contained within the above listed street closures from 6 AM on March 9, 2026, until 12 PM on March 17, 2026.

Parking would be prohibited from 6 AM on March 9, 2026, until 12 PM on March 17, 2026.

and would include the:

- Southside of Grape Street between Pacific Highway and Harbor (except for the bus turnout closest to PCH, which will remain accessible.)
- Frontage Road east of Harbor Drive between Grape Street and Hawthorne Street and it's associated spaces. This lot would be used for (4) ADA labelled spaces to replace the spaces closed on Harbor Drive between Ash and Grape.
- West side Pacific Highway between Grape and Ash.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
