NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Rock 'n' Roll San Diego Marathon and Half Marathon

COMMUNITY PLAN AREA: Balboa Park, Uptown, Greater Golden Hill, North Park, Normal Heights, City Heights, Old Town, Midway-Pacific Highway, Peninsula, Ocean Beach, Mission Bay Park, Mission Valley, Linda Vista, Downtown

COUNCIL DISTRICT: 2,3,7,9

LOCATION: Balboa Park, Presidio Park, roadways throughout the City, County Waterfront Park

PROJECT DESCRIPTION: Special Event Permit for that portion within the City's right-of-way or parks' area jurisdiction of a marathon/half marathon race and post-race concert/festival that would include the temporary use of the races, stages, tents, temporary structures, fencing and/or barriers, tables, chairs, portable restrooms, trash/recycling containers, generators, drones, exhibits, refreshments, food trucks, and entertainment that would occur on May 31, 2026, throughout the City of San Diego. The post-race concert/festival would occur at Waterfront Park, under the County's jurisdiction. Noise associated with the event activities and set-up/dismantling would occur from 7 AM on May 30, 2026, until 2 PM on June 1, 2026. There would be multiple stages with entertainment throughout the races, and sound amplification would occur from 5:30 AM until 3 PM on May 31, 2026. Set-up would occur from 7 AM until 4 PM on May 30, 2026, and from 2 AM until 6:15 AM on May 31, 2026. The event would occur from 6:15 AM until 4 PM on May 31, 2026. Dismantling would occur from 3 PM until 6 PM on May 31, 2026, and from 8 AM until 2 PM on June 1, 2026. The race would utilize the western portion of Balboa Park between Sixth Avenue and Quince Street for the starting area for both the marathon and half marathon races. The marathon route would begin on Sixth Avenue at Quince Street and finish on Ash Street at Union Street. See marathon route description attached for complete marathon details.

Road and parking closures would be associated with this event. (See grid attached for complete details on closures.)

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
