
Item 2: Land Acknowledgment

Propose projects or programs that serve
Community Power customers*



Be led by a nonprofit with 501(c)(3) status or another tax-exempt organization (such as a public agency or higher education institution) with proven experience serving community members through projects or programs



Propose projects or programs that fit within either the Clean Energy Infrastructure or Clean Energy Programming funding track and align with one or more of the following focus areas:

- Increased overall energy literacy
- Energy-focused educational programming that encourages clean energy use, particularly for youth
- Indoor and/or outdoor air quality improvement related to electrification
- Clean energy workforce development
- Improved energy resilience to ensure communities can avoid, prepare for, minimize, adapt to and recover from energy disruptions


Energy Projects at Municipal Facilities

Timeline and Current Status

- Short list of vendors established 2023 – ESCOs/PV/BESS/Renewable Microgrids
- Integrating selected vendors into new construction CIPs
- 4 renewable microgrids operational Q4 FY26
- 1.7 MW solar PV and 3.5 MW battery storage in ESPC scope of work

Opportunities for the Climate Advisory Board

- Share future opportunities with industry contacts if/when RFPs are issued



ESPC Portfolio 1

- 40 buildings and 39,000 streetlight retrofits
- Electrification of 23 buildings – libraries, recreation centers and Ridgehaven Green Bldg
- New efficient HVAC, lighting, water heaters, water fixtures, transformers
- 1.7 MW of solar PV and 3.5 MW battery energy storage (17 systems)
- Annual reductions of 263 MTCO2e
- Replacing over 80 HVAC systems, many well beyond their useful life
- \$16M in retrofits at Ridgehaven including overdue roof and HVAC replacement
- First reading approved by Council Jan 27, 2026


Fleet Electrification

Timeline and Current Status

- 356 EVs out of 5,037 total fleet vehicles
- Working to access more EV options via fleet vehicle providers/contracts
- 90 Level 2 Chargers installed across 10 sites
- Fleet electrification study completed
 - Electric capacity analysis & outline of EVSE needs for 3,505 anticipated EVs
- Fleet Charging as a Service (CaaS) RFP to be issued Q3 FY26
- Retail charging pilot program launching soon
- Fleet Charging Plans due Jan 2026
