- Apply online at MAACproject.org/SDSWAssistance. Applications for assistance this year will be reviewed and approved on an ongoing basis through April as funding remains available. The deadline to apply for assistance toward your 2025-2026 fee is April 30, 2026. Watch for updates after this date to apply for assistance toward your 2026-2027 fee.
- Additional assistance may be available for certain homeowners who meet the eligibility requirements above AND are currently enrolled in a County payment plan for past-due property taxes. Learn more at MAACproject.org/SDSWAssistance.



The City of San Diego, Environmental Services Department (ESD) is partnering with the Metropolitan Area Advisory Committee on Anti-Poverty of San Diego County, Inc. (MAAC) to launch a Financial Assistance Program to help eligible homeowners subject to the new Solid Waste Management Fee.

If your household income (adjusted gross) is within certain ranges or a household member participates in one or more specified assistance programs, you may qualify for help covering part or all of this year's Solid Waste Management Fee.

WHO IS ELIGIBLE?

You may qualify if **both** of the following are true:

- You own and live in the home as your primary residence.
- Your home is eligible to receive trash and recycling collection from the City.

In addition, you must meet **one** of the following qualifications:

1. Your household income (adjusted gross) is **at or below 60% of California's State Median Income.**

OR

2. At least **one person** in your household is enrolled in **one** or more of the following assistance programs:
 - **Medi-Cal**
 - **CalFresh**
 - **CalWORKs**
 - **Low Income Home Energy Assistance Program (LIHEAP)**

HOW MUCH ASSISTANCE IS AVAILABLE?

- If you meet the criteria above and are approved for assistance, you will receive \$261.60 (half of your fee).
- Additional assistance may be available for certain homeowners who meet the eligibility requirements above AND are currently enrolled in a County payment plan for past-due property taxes. Eligible residents may receive up to \$523.20 (the full fee amount). Learn more at MAACproject.org/SDSWAssistance.

To be eligible for assistance, you must apply. Funding is limited and available on a first-come, first-served basis.
