Conditional Use Permit (CUP) (PMT-3379540) to amend a previously approved Centre City Development / Coastal Development Permit / Centre City Planned Permit / Conditional Use Permit (Permit No. 2016-30) to allow the off-site sale of distilled spirits, exterior alcohol signage, and deviations to reduce minimum container sizes and extend alcohol sales hours for Laurel Pacific Valero Gas Station, located at 2499 Pacific Highway, at the southeast corner of West Laurel Street and Pacific Highway, in the Little Italy neighborhood of the Downtown Community Plan area, the Mixed Commercial land use district of the Centre City Planned District, the Transit Priority Area Overlay.

The Project is consistent with the previously certified [Downtown Final Environmental Impact Report](#) as amended and no additional environmental document is required under the California Environmental Quality Act.

**ITEM 2: 6273 OSLER STREET – PROJECT NO. PRJ-1122535****Staff:** Robin MacCartee**City Council District:** 7**Plan Area:** Linda Vista

Tentative Map Waiver to convert an existing two-unit, multiple dwelling unit single-story structure with two detached garages, into two condominium units utilizing the same existing multiple dwelling unit single-story structure and two detached garages. The condominium conversion does not propose any development with the Tentative Map application. The 0.24-acre site is located at 6273 and 6275 Osler Street, also known as Assessor's Parcel Number (APN) 431-592-01-00 in the Residential Multiple Unit (RM-1-1) base zone, the Airport Land Use Compatibility Overlay Zone (Montgomery Field), the ALUCP Airport Influence Area (Montgomery Field - Review Area 2), the FAA Part 77 Noticing Area, and a Very High Fire Hazard Severity Zone within the Linda Vista Community Plan area.

This project was determined to be categorically exempt pursuant to Section 15305, Minor Alterations in Land Use Limitations of the California Environmental Quality Act.

## **HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS**

### **TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

### **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1<sup>st</sup> Floor, San Diego, CA 92108.
