**Plan Area:** La Jolla

Special Use Permit and Site Development Permit for the preservation and reuse of an existing, three story, 16,683 square-foot single-dwelling unit (SDU), a designated heritage structure, to include relocation of the SDU to the first floor, interior remodel to accommodate a 19-room hotel and the addition of a bulb-out pedestrian walk and valet parking zone at 484 Prospect Street. The 0.28-acre site is in the LJPD-5A (La Jolla Planned District 5A) zone, the Coastal Overlay Zone (Appealable and Non-Appealable Areas), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, a Parking Standards Transit Priority Area, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15332 (In-fill Development) of the California Environmental Quality Act.

**ITEM 2: 7856 LA JOLLA VISTA DRIVE – PROJECT NO. PRJ-1123371**

**Plan Area:** La Jolla

Site Development Permit for modifications and additions to an existing 4,764-square-foot, one-story single dwelling unit to create a new, one-story, 5,460-

square-foot single dwelling unit. Modifications include 1,768 square feet of demolition and a 3,010-square-foot remodel of the existing structure. Additions include 2,450 square feet added to the existing primary structure, construction of a new, detached 694-square-foot accessory dwelling unit (ADU) that is separated from the primary structure by a covered exterior overhang, which will serve as a new attached carport. Other additions include a new, detached 818-square-foot garage, and a new, detached 61-square-foot tennis pavilion. The project will also include new retaining walls, and a new swimming pool. The 1.52-acre site is located at 7854 and 7856 La Jolla Vista Drive, also known as Assessor's Parcel Number (APN) 346-742-11-00. The 1.52-acre site is in the LJSPD-SF (La Jolla Shores Planned District, Single Family) zone, the Airport Land Use Compatibility Overlay Zone (MCAS Miramar), the ALUCP Airport Influence Area for MCAS Miramar (Review Area 2), the Coastal Height Limit Overlay Zone, and a Very High Fire Hazard Severity Zone within the La Jolla Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (Existing Facilities) and Section 15303 (New Construction or Conversion of Small Structures).

## **HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS**

### **TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

### **HOW TO PROVIDE WRITTEN COMMENTS:**

**For Agenda Items and Non-Agenda Public Comment:** Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 500 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

**Written Materials:** Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

### **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1<sup>st</sup> Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the Edric Doringo Hearing Room on the 1<sup>st</sup> floor of the Mission Valley Development Services Department Building in a binder labeled “Hearing Officer Binder”. Late arriving materials received during the Hearing Officer meeting are available for review by verbally requesting the materials from Legislative staff.
