

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO
AND UNIVERSITY OF SAN DIEGO FOR EVALUATION OF PEACEMAKER PROJECT
AND CALVIP GRANT**

This First Amendment to the Agreement between the City of San Diego and University of San Diego Evaluation of Peacemaker Project and CalVIP Grant (First Amendment) is entered into by and between the City of San Diego, a municipal corporation (City), and University of San Diego (Contractor) (collectively, the Parties).

RECITALS

1. City and Contractor entered into an Agreement between the City of San Diego and University of San Diego (Agreement) effective on March 20, 2024.
2. The Agreement may be amended by written agreement executed by duly authorized representatives of both Parties.
3. The Parties wish to amend the Agreement to increase the compensation by \$94,702.20 to a new not to exceed amount of \$365,184.20 and to extend Contractor's evaluation activities to cover the additional activities undertaken by the partners, and to conduct additional research in the communities to better understand the impact of rapid response de-escalation activities.
4. All initially capitalized terms herein shall have the same meaning as in the Agreement unless otherwise specifically defined herein.

NOW THEREFORE, in consideration of the above recitals and the mutual promises contained herein, the Parties agree as follows:

TERMS

1. **Section 3.1** of the Agreement is revised in its entirety to read as follows:
Amount of Compensation. The City shall pay the Contractor for performance of all Services rendered in accordance with this Agreement and any amendments thereto, including reasonably related expenses, **in an amount not to exceed \$365,184.20.**
2. **Section C. Contractors Roles and Responsibilities of Exhibit A** of the Agreement is revised to replace Andrew Blum with Dustin Sharp as Executive Director, Kroc Institute for Peace and Justice.
3. This First Amendment will be effective when signed by both parties and approved by the City Attorney in accordance with Charter section 40.

4. All provisions of the Agreement not addressed in this First Amendment remain in full force and effect.
