**Item 8: Information Items**

**a) Resiliency topic: Climate Change Implications for Homelessness, Jolly Noor (she/her), Research Analyst at the Centre for Addiction and Mental Health.**

Jolly Noor provided an overview of the research on extreme heat event impacts on people experiencing homelessness, including key themes of research and identified areas for future research.

Board members discussed research presented and applicability to the San Diego Region.

**b) Stormwater 101, Patrick McDonough, Senior Attorney, San Diego Coastkeeper.**

Coastkeeper presented an overview of the stormwater system and funding challenges currently facing the City to address aging infrastructure and climate change impacts.

Board members asked questions regarding stormwater reuse, evaluation of outreach efforts. Board member discussion touched on cost of stormwater reuse and potential regulatory constraints, understanding what may be on the ballot for 2026, and the trade offs between a general sales tax measure versus stormwater specific fee.
