ITEM 1: 3060 CARMEL VALLEY ROAD – PROJECT NO. PRJ-1140510

Plan Area: Carmel Valley

A Conditional Use Permit to allow the sale of beer and wine for off-site consumption under a Type 20 Alcoholic Beverage Control (ABC) license at a convenience store governed by Coastal Development Permit (CDP) PMT-3161704 (Project No. PRJ-1054862). No physical development is proposed with this permit. The 0.88-acre site is located at 3060 Carmel Valley Road in the CC-1-3 (Commercial-Community) zone, the Coastal Overlay Zone (Non-Appealable Area), a Transit Priority Area, and a Very High Fire Hazard Severity Zone within the Carmel Valley Community Plan. This development is within the Coastal Overlay Zone, and the application was filed on August 18, 2025.

A California Environmental Quality Act (CEQA) Section 15162, Subsequent EIRs and Negative Declaration Consistency Evaluation, was conducted against the previously adopted Negative Declaration No. 87-1054, and the evaluation concluded that no additional environmental document is required.

ITEM 2: MONTORO ESTATES – PROJECT NO. PRJ-1135846

Plan Area: La Jolla

A Coastal Development Permit and Site Development Permit for the construction of a two-story 9,480-square-foot single dwelling unit with a walkout basement, pool, spa, and main and lower-level garages on an empty lot addressed as 2545

Ruette Nice in the LJSPD-SF (La Jolla Shores Planned District – Single Family) zone. The project site is also in the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, a High Paleontological Sensitivity Area, and the Parking Impact Overlay Zone within the La Jolla Community Plan and Local Coastal Program Land Use Plan. This development is within the Coastal Overlay Zone, and the application was filed on May 30, 2025.

The project was determined to be categorically exempt from the California Environmental Quality Act pursuant to Section 15303 (New Construction or Conversion of Small Structures) and 15332 (In-fill Development Projects).

ITEM 3: *1720 TORREY PINES ROAD – PROJECT NO. PRJ-1111223

Plan Area: La Jolla

A Coastal Development Permit and Site Development Permit to partially demolish an existing one-story, 3,574-square-foot single dwelling unit and construct a 10,691-square-foot addition, resulting in a two-story, 14,265-square-foot single dwelling unit with attached garage over a basement level. The 0.91-acre site is located at 1720 Torrey Pines Road in the RS-1-7 (Residential Single Dwelling Unit) zone, the Coastal Overlay Zone (Appealable Area, First Public Roadway), and the Coastal Height Limit Overlay Zone within the La Jolla Community Plan and Local Coastal Program Land Use Plan. Approved permits will address the current Building and Land Use Enforcement case number CE-0536464. This development is within the Coastal Overlay Zone, and the application was filed on February 26, 2024.

[Mitigated Negative Declaration No. 1111223/SCH No. 2025070372](#) was prepared in accordance with the California Environmental Quality Act Statute and Guidelines. A Mitigation Monitoring and Reporting Program will be implemented to reduce impacts to below a level of significance.

ITEM 4: WOODFORD DRIVE RESIDENCE – PROJECT NO. PRJ-1134889

Plan Area: La Jolla

A Site Development Permit for the construction of a two-story 6,562-square-foot single dwelling unit with an attached garage and a two-story, 967-square-foot detached accessory dwelling Unit on a vacant lot located at Assessor Parcel Number 346-741-31-00 on Woodford Drive, west of and adjacent to 2975 Woodford Drive. The 0.46-acre site is in the LJSPD-SF (La Jolla Shores Planned District – Single Family) zone, the Coastal Height Limit Overlay Zone, and the Airport Land Use Compatibility Overlay Zone (MCAS Miramar) within the La Jolla Community Plan.

The project was determined to be categorically exempt from the California Environmental Quality Act pursuant to Section 15303 (New Construction or Conversion of Small Structures).

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108.
