An application for a Map Waiver to convert two existing dwelling units and two accessory dwelling units into four new condominiums located at 3321-3323 Apache Avenue in the RM-1-1 Base Zone and within the Clairemont Mesa Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act pursuant to Section 15303 (New Construction or Conversion of Small Structures) on February 6, 2026, and the opportunity to appeal this environmental determination ended on February 23, 2026.

ITEM 2: *8204 LA JOLLA SHORES DRIVE – PROJECT NO. PRJ-1126220

Plan Area: La Jolla

A Coastal Development Permit and Site Development Permit to demolish an existing one-story, 3,214 square-foot single-dwelling unit with attached garage and construct a new two-story, 3,525-square-foot single-dwelling unit with attached garage and associated site improvements at 8204 La Jolla Shores Drive. The 0.14-acre site is in the LJSPD-SF zone (La Jolla Shores Planned District - Single Dwelling Unit), the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, and a Parking Standards Transit Priority Area within the La Jolla Community Plan. This

development is within the Coastal Overlay Zone and the application was filed on December 13, 2024.

[Mitigated Negative Declaration No. 1126220/SCH No. 20251210955](#) was prepared in accordance with the California Environmental Quality Act Statute and Guidelines. A Mitigation Monitoring and Reporting Program will be implemented to reduce impacts to below a level of significance.

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be received by the business day prior for it to be distributed to the Hearing Officer. All webform comments are limited to 500 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the Edric Doringo Hearing Room on the 1st floor of the Mission Valley Development Services Department Building in a binder labeled “Hearing Officer Binder”.
