A graduate of an apprenticeship program means either of the following:

- (1) An individual that has been issued a certificate of completion under the authority of the California Apprenticeship Council for completing an apprenticeship program approved by the Chief pursuant to Section 3075 of the Labor Code, or
- (2) An individual that has completed an apprenticeship program located outside California and approved for federal purposes pursuant to the apprenticeship regulations adopted by the federal Secretary of Labor.

Subject: Letter to Achieve – Skilled and Trained Workforce Compliance (October & November 2025)

To Whom It May Concern,

This letter is submitted in response to the Skilled and Trained Workforce (STW) requirements for the above-referenced project.

During the months of October and November 2025, our Skilled and Trained workforce percentage was approximately 50%, which was below the required 60% threshold for those individual reporting periods.

It is important to note that during each of those two months, we employed only **two (2) journeymen** on the project. Of those two journeymen, **one met the Skilled and Trained criteria and one did not**, resulting in the 50% ratio for those specific months. The shortfall was therefore due to minimal manpower during those periods rather than a broader workforce compliance issue.

Over the full duration of the project, we employed a total of 25 journeymen. Of those 25 journeymen, 16 meet the Skilled and Trained criteria, reflecting an overall project Skilled and Trained ratio of **64%**, which exceeds the required 60% threshold.

We remain fully committed to compliance with Skilled and Trained Workforce requirements and will ensure that a minimum of 60% of all journeymen employed on the project meet the Skilled and Trained classification for all future reporting periods.

We appreciate the opportunity to clarify this matter and confirm our continued commitment to meeting and exceeding workforce compliance standards.
