Someone, it isn't obvious who, has paid a firm in Pasadena to apply to the California State Office of Historic Preservation for approval of the National Register of Historic Places Multiple Property Documentation Form for the San Diego Bungalow Courts Multiple Property Listing. <input type="checkbox"/></p> <p>The City of San Diego has not approved the use of a Multiple Property Listings (MPL) form of historic district in San Diego and yet this would create one at the federal level that outside groups could then use to stop new housing developments in San Diego by adding new properties to the listing. The property owners would have little if any warning, the City Council would not be able to overturn the designation, and yet the property would be subject to the city's historic regulations as if they had been approved by the city. <input type="checkbox"/></p> <p>Item # 1 is even listed on the consent agenda as if no one were paying attention. Did the HRB staff not tell the Mayor, City Council members, the Planning Commission, and Planning Director about this when they were first given 60 days to review and comment on it?<input type="checkbox"/></p> <p>I urge the city to pull this item from the HRB agenda and direct the Planning Department to actively oppose the South Environmental application.
