NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Into the Horizon Music Festival 2026

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: County of San Diego Water Park at the Embarcadero, Harbor Drive, Access Road, Grape Street, Pacific Highway, Ash Street (see attached map)

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within the City of San Diego's right-of-way jurisdiction that would be associated with a two-day music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on June 27 and 28, 2026. The event permit would be issued by the County of San Diego. Alcohol would be served from 3 PM until 10:30 PM on June 27, 2026, and from 3 PM until 9:30 PM on June 28, 2026. Sound amplification would occur at 9 AM for sound check and from 1 PM until 11 PM on June 27 and 28, 2026. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on June 23, 2026, until 8 PM on June 30, 2026. Set up would occur from 6 AM until 10 PM on June 23, 24, and 25, 2026, and from 6 AM until 11:55 PM on June 26, 2026. The event would occur from 3 PM until 11 PM on June 27, 2026, and from 3 PM until 10 PM on June 28, 2026. Dismantling would occur from 12:05 AM until 11:55 PM on June 29, 2026, and from 12:05 AM until 8 PM on June 30, 2026. Approximately 16,500 attendees are anticipated throughout the duration of the event. See attached map.

Road and parking closures associated with the event would include:

- Ash Street from North Harbor Drive to Pacific Highway from 6 PM until 12 AM on June 27 and 28, 2026
- One northbound lane (lane closest to Waterfront Park) and the bike lane on North Harbor Drive from Ash Street to Grape Street from 6 AM on June 23, 2026, until 8 PM on June 30, 2026.

Street parking closures associated with the event would include the:

- The eastern-most curb of Harbor Drive, adjacent to Waterfront Park, from Ash Street to Grape Street from 6 AM on June 23, 2026, until 8 PM on June 30, 2026
- Approximately (5) parking spaces on the south side of Grape Street between North Harbor Drive and Pacific Highway from 12 AM on June 23, 2026, until 8 PM on June 30, 2026
- Approximately (10) parking spaces on the west side of Pacific Highway closest to Grape Street from 12 AM on June 23, 2026, until 8 PM on June 30, 2026
- Approximately (10) parking spaces on the west side of Pacific Highway closest to Grape Street from 12 AM on June 27, 2026, until 11:45 PM on June 28, 2026, in addition to the above-mentioned closure for these dates only

- All parking spaces, approximately (20), on Frontage Road access from 12 AM on June 23, 2026, until 8 PM on June 30, 2026

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
