A graduate of an apprenticeship program means either of the following:

- (1) An individual that has been issued a certificate of completion under the authority of the California Apprenticeship Council for completing an apprenticeship program approved by the Chief pursuant to Section 3075 of the Labor Code, or
- (2) An individual that has completed an apprenticeship program located outside California and approved for federal purposes pursuant to the apprenticeship regulations adopted by the federal Secretary of Labor.

The work performed during this period totaling 80 man-hours over the course of 3 days was unplanned/emergency work to repair a leak that was flooding the excavation. As such, CJA mobilized available resources with no notice or opportunity to hire or seek “trained” individuals.

Please understand that CJA has been under contract for this project since November of 2021. During this time CJA has accumulated over 33,500 man-hours without a single month of non-compliance.

We understand the importance of utilizing a skilled and trained workforce on public works projects and are committed to meeting these requirements. Moving forward, we trust the remaining work will be planned and will continue to do the following:

- **Prioritize employing graduates of apprenticeship programs:**
 We will actively seek to hire individuals who have successfully completed apprenticeship programs approved by the Chief of the Division of Apprenticeship Standards in California or equivalent programs for our signatory trades.
- **Supplement with skilled journeypersons:**
 When necessary, we will employ journeypersons who have equivalent on-the-job experience to apprenticeships, as defined in the California Labor Code Section 1777.5.
- **Utilize certified apprentices:**
 We will ensure that any apprentices working on the project are enrolled in and actively participating in an approved apprenticeship program.

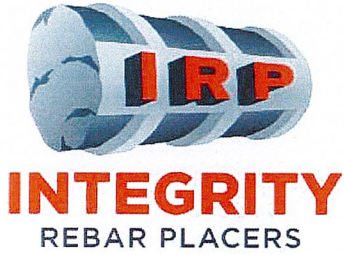


