- Please provide the subterranean area of the proposed project and show its footprint on the L1 site plan.
- Please provide dimensions for L0 on the "L0 Basement/Garage Plan" drawing.
- Please provide the SDMC reference for not including the 91 SF from L0 (shown on the drawing sheet labeled "Project Data and Compliance Chart") in the GFAR calculation.
- Please provide the 300 ft neighborhood survey of setbacks and FAR's.
- Please provide the Report of Preliminary Geotechnical Investigation dated July 13, 2025, and the Report of Geologic Fault Investigation dated July 7, 2023, referenced in the letter from Geotechnical Exploration, Inc. dated February 5, 2026.
