Plan Area: Clairemont Mesa

An application for a Site Development Permit to legalize and modify existing keystone retaining walls previously constructed on a 1.55-acre site with an existing single dwelling unit located at 3810 Gila Court. The retaining walls are adjacent to environmentally sensitive lands, in the RS-1-7 (Residential Single Family) zone and the Clairemont Mesa Height Limitation Overlay Zone within the Clairemont Mesa Community Plan.

This project was determined to be categorically exempt pursuant to Sections 15301 (Existing Facilities) and 15303 (New Construction) of the California Environmental Quality Act.

ITEM 2: SEVENTH & ISLAND TEMPORARY SURFACE PARKING LOT – PROJECT NO. PRJ-1140032

City Council District: 3

Plan Area: Downtown

An application for a Conditional Use Permit (Process 3) to allow a temporary surface parking lot at 502 Seventh Avenue, located on the 15,033-square-foot property at the northwest corner of Seventh Avenue and Island Avenue, in the East Village neighborhood of the Downtown Community Plan area. The site is within the Employment/Residential Mixed-Use land use district of the Centre City Planned District, Sustainable Development Area Overlay, and Council District 3.

A CEQA Guideline Section 15162 Consistency Evaluation was prepared against the previously certified [City of San Diego Downtown Environmental Impact Report SCH No. 2003041001](#), as this activity is within the scope of the program approved earlier, and the program EIR adequately describes the activity for the purposes of CEQA.

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be received by the business day prior for it to be distributed to the Hearing Officer. All webform comments are limited to 500 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.
