#### **ITEM 1: 10509 VISTA SORRENTO PKWY – PROJECT NO. PRJ-1062368**

**City Council District:** 6  
**Plan Area:** Mira Mesa

An application for a Coastal Development Permit, Neighborhood Development Permit, Site Development Permit and Public Service Easement Vacation for the demolition of a four-story building, trash enclosure, telecommunications structure, mechanical equipment enclosure and associated site improvements and construction of a 112,400-square-foot four-story commercial office building, a 189,795-square-foot six-story parking garage, and associated site improvements. The project would also vacate a four-foot wide, 4,314-square-foot (0.09-acre) Sewer, Water, Drainage and Public Utilities Easement.

The 5.58-acre site is located at 10509 Vista Sorrento Parkway in the IL-3-1 (Industrial-Light) zone, the Coastal Overlay Zone (Non-Appealable Area), the Parking Impact Overlay Zone, the Airport Land Use Compatibility Overlay Zone for Marine Corps Air Station (MCAS) Miramar, the Airport Land Use Compatibility Plan (ALUCP) Airport Influence Area for MCAS Miramar (Review Area 1), the 60-65 dB CNEL noise contour and Accident Potential Zone II for MCAS Miramar, the Federal Aviation Administration Part 77 Noticing Area (MCAS Miramar), Complete Communities Mobility Choices Mobility Zone 2, and a Very High Fire Hazard Severity Zone within the Mira Mesa Community Plan. This development is within the Coastal Overlay Zone, and the application was filed on July 12, 2022.

A California Environmental Quality Act (CEQA) Guidelines section 15162 Consistency Evaluation was prepared against the previously certified Program Environmental Impact Report SCH No. 2022090061, as this activity is within the scope of the program approved earlier, and the program EIR adequately describes the activity for the purposes of CEQA. A Mitigation Monitoring and Reporting Program will be implemented consistent with the previous environmental document.

**ITEM 2: 10641 SCRIPPS SUMMIT COURT – PROJECT NO. PRJ-1138357**

**Plan Area:** Sabre Springs

An application for a Site Development Permit and a Conditional Use Permit to install three (3) 12.5-foot diameter satellite antennas over 6-foot high by 6-inch diameter pipe supports set in 2.5-foot diameter “sono” tube caissons and associated improvements, including the removal of minor landscaping at a site with an existing commercial office building, located at 10641 Scripps Summit Ct. The 12.78-acre site is in the IP-2-1 zone within the Sabre Springs Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303 (New Construction or Conversion of Small Structures).

**ITEM 3: 1750 CAMINO DEL RIO NORTH – PROJECT NO. PRJ-1138833**

**Plan Area:** Mission Valley

An application for a Conditional Use Permit for an assembly and entertainment use in an existing two-story commercial building within an existing shopping center located at 1750 Camino Del Rio North. The 46.93-acre site is in the Employment Mixed-Use (EMX-2) zone, the Airport Land Use Compatibility Overlay Zone (San Diego International Airport, or SDIA), the Airport Influence Area (SDIA – Review Area 2), the Federal Aviation Administration Part 77 Noticing Area (SDIA), and a Transit Priority Area within the Mission Valley Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

**ITEM 4: 3751 OCEAN FRONT WALK – PROJECT NO. PRJ-1124856**

An application for a Tentative Map Waiver to allow for condominium ownership of four existing residential units located at 3751 and 3753 Ocean Front Walk. The 0.21-acre site is in the MBPD-NC-N (Mission Beach Planned District-Neighborhood Commercial-North) zone, the Coastal Overlay Zone (Coastal Commission permit jurisdiction), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Parking Standards Transit Priority Area, and a Transit Priority Area within the Mission Beach Precise Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

## HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

### **TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

### **HOW TO PROVIDE WRITTEN COMMENTS:**

**For Agenda Items and Non-Agenda Public Comment:** Submit using the [webform](#), indicating the comment type and item number (if relevant). Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

### **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1<sup>st</sup> Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the Edric Doringo Hearing Room on the 1<sup>st</sup> floor of the Mission Valley Development Services Department Building in a binder labeled “Hearing Officer Binder”.
