For valuable consideration, receipt of which is hereby acknowledged, _____

HEREBY GRANT(S) to the City of San Diego, a municipal corporation, in the County of San Diego, State of California, a permanent easement for **open space purposes**, and relinquishes any and all rights to construct or maintain fences; to remove live trees and shrubs, to plant and irrigate trees and shrubs, to change the grade; or to otherwise change the open space character of the land, unless approved by the City, over, under and across all that real property situated in the City of San Diego, County of San Diego, State of California, described as follows:

See exhibit "A" attached hereto and exhibit "B" attached for illustration purposes

Reserving to the owner of the fee underlying said easement, granted herein, the right to grant easements to any public utility company for distribution facilities, provided the same are installed underground; and the right to maintain fire-breaks, trim or remove brush and otherwise perform preventive measures required by the fire department to protect structures and other improvement from potential fires. Responsibility for maintenance of said land shall remain with the owner of the fee title of said land and nothing contained herein shall be construed to assign any maintenance responsibility to the City of San Diego, nor shall anything contained herein be construed to confer any rights to the general public.
