An application for a Site Development Permit for the construction of a 1,214-square-foot two-story addition to an existing single-dwelling unit that contains an existing attached junior accessory dwelling unit. The project proposes a 482-square-foot attached two-car garage, a 732-square-foot accessory dwelling unit, and associated site improvements on a 0.46-acre site located at 8151 Calle Del Cielo in the LJSPD-SF (La Jolla Shores Planned District - Single-Family) zone. The site is also within the Coastal Overlay Zone (Non-Appealable), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, and a Very High Fire Hazard Severity Zone (VHFSZ) within the La Jolla Community Plan and Local Coastal Program (LJCP). This development is within the Coastal Overlay Zone, and the application was filed on November 9, 2023.

This project was determined to be categorically exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15303 (New Construction or Conversion of Small Structures).

ITEM 2: FISHER'S HOUSE LIVE ENTERTAINMENT – PROJECT NO. PRJ-1139084**Staff:** Katelyn Cleveland**City Council District:** 3**Plan Area:** Downtown

An application for a Conditional Use Permit for indoor non-acoustic (amplified) live entertainment for a restaurant/bar within the approximately 6,000-square-foot tenant space on the ground floor of the building situated on an approximate 18,000-square-foot lot located at 555 West Beech Street between Columbia and India Street in the Little Italy neighborhood of the Downtown Community Plan area, Employment/ Residential Mixed-Use land use district of the Centre City Planned District, and the Transit Priority Area Overlay. A California Environmental Quality Act (CEQA) Guideline Section 15162 Consistency Evaluation was conducted against the previously adopted [2006 Downtown Final Environmental Impact Report \(FEIR\) \(SCH No. 2003041001\)](#) as [addended](#) and the [City of San Diego Climate Action Plan \(CAP FEIR\) \(SCH# 2015021053\)](#), and the evaluation concluded that no new or subsequent environmental document is required. This activity is within the scope of the program approved earlier, and the Downtown FEIR and CAP FEIR adequately describe the activity for the purposes of CEQA.

ITEM 3: 8303 PRESTWICK – PROJECT NO. PRJ-1109965**Staff:** Will Rogers**City Council District:** 1**Plan Area:** La Jolla

An application for a Site Development Permit and Coastal Development Permit for the demolition of an existing 2,503-square-foot house and the construction of a two-story 10,297-square-foot house with associated site improvements. The 0.55-acre site is located at 8303 Prestwick Drive in the LJSPD-SF (La Jolla Shores Planned District – Single-Family) zone. The site is also in the Coastal Overlay Zone (Non-Appealable), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, and a Very High Fire Hazard Severity Zone within the La Jolla Community Plan and Local Coastal Program. This development is within the Coastal Overlay Zone, and the application was filed on February 8, 2024. This project was determined to be categorically exempt from the California Quality Act pursuant to CEQA Guidelines Section 15302 (Replacement or Reconstruction).

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*
