NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - CRSSD Music Festival - Fall 2026

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: County of San Diego Waterfront Park, 1600 Pacific Highway

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within the City of San Diego's right-of-way jurisdiction that would be associated with a two-day music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on September 26 & 27, 2026. The event permit would be issued by the County. Alcohol would be served from 12 PM until 10:30 PM on September 26, 2026, and from 12 PM until 9:30 PM on September 27, 2026. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on September 21, 2026, until 12 PM on September 30, 2026. Set up would occur from 6 AM until 11 PM on September 21-25, 2026, and from 6 AM until 12 PM on September 26-27, 2026. The event would occur from 12 PM until 11 PM on September 26, 2026, and from 12 PM until 10 PM on September 27, 2026. Dismantling would occur from 6 AM until 11 PM on September 28, 2026, and from 6 AM until 12 PM on September 29-30, 2026. Approximately 16,500 attendees are anticipated on each day of the event. Road, parking, and bike lane closures would be associated with the event from 6 AM on September 21, 2026, until 8 AM on September 30, 2026, and would include:

- One lane of northbound traffic on North Harbor Drive between Ash Street and Grape Street
- Frontage Road (both sides) between Grape Street and Hawthorne Street
- Westside street parking on Pacific Highway between Grape Street and Ash Street
- Southside street parking on Grape Street between Harbor Drive and Pacific Highway
- Bike lane on east side of North Harbor Drive between Ash Street and Grape Street
- Ash Street between Pacific Highway and Harbor Drive (from 6 AM on September 26, 2026, until 11:45 PM on September 27, 2026)

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the

required appeal fee, with a check payable to: City Treasurer.
