- b. Appeals Policy-- for CPGs

In the not too distant past CPGs could initiate an appeal of projects. There was no fee associated with that action, in recognition of the relationship of the community planning group's status as an elected advisory group.

More recently, the number of appeals permitted (without a fee) was limited.

Currently CPGs have no special acknowledgement, and are required to pay the same fee as any private individual or other group, around \$2,500.

Should the GGHPG join other CPGs requesting that those fees be waived on some basis? (subject came up at the July CPC meeting)

I believe that the Golden Hill group has not often used that prerogative, only filing an appeal once in twenty years or more, but it can be an important tool.

- c. Affordable Homes Action Plan - comment. This program, currently under consideration, includes recommendations re use of City owned properties such as libraries and maintenance facilities as sites for development of housing. The yards at 20th & B are apparently included in this discussion, and are covered in the GGHCP. In the past the planning group has encouraged implementation of that element of the 2016 GH Community Plan, or comment otherwise?
